L 7	SECTION 2. NEW LAW A new section of law to be codified

- 21 SECTION 3. NEW LAW A new section of law to be codified
- 22 in the Oklahoma Statutes as Section 3273 of Title 63, unless there
- 23 is created a duplication in numbering, reads as follows:

- 1 A. 1. The Oklahoma Legislature finds that the delivery of
- 2 graduate medical education programs at the Oklahoma State University
- 3 Center for Health Sciences as well as the preparation of osteopathic
- 4 physicians for service within the state will be enhanced through the
- 5 establishment of a Graduate Medical Education Public Trust Authority
- 6 and the creation of Graduate Medical Education (GME) hospital
- 7 districts pursuant to the Oklahoma State University Graduate Medical
- 8 Education Public Trust Act.
- 9 2. The purpose of the Oklahoma State University Graduate
- 10 Medical Education Public Trust Act is to provide maximum utilization
- 11 and efficient administration in delivering graduate medical
- 12 education programs by the Oklahoma State University Center for
- 13 Health Sciences in cooperation with hospitals located within a
- 14 Graduate Medical Education hospital district.
- B. There is hereby created the Oklahoma State University
- 16 Graduate Medical Education Public Trust Authority, an agency of the
- 17 State of Oklahoma, a body corporate and politic, with powers of
- 18 government and with the authority to exercise the rights, privileges
- 19 and functions specified in the Oklahoma State University Graduate
- 20 Medical Education Public Trust Act. The Oklahoma State University
- 21 Graduate Medical Education Public Trust Authority is an agency of
- 22 the State of Oklahoma covered by the Governmental Tort Claims Act
- 23 and is granted herein the general powers and authorities granted to

- 6 1. One member shall be appointed by the Governor, with the
- 7 advice and consent of the Senate;
- 8 2. One member shall be appointed by the President Pro Tempore
- 9 of the Senate;
- 3. One member shall be appointed by the Speaker of the House of
- 11 Representatives;
- 12 4. One member shall be the Director of the Oklahoma Health Care
- 13 Authority or the director of the successor organization responsible
- 14 for Medicaid, or his or her designee;
- 15 5. One member shall be the President of the Oklahoma State
- 16 University Center for Health Sciences; and
- 17 6. One member shall be the Chief Executive Officer of the
- 18 Oklahoma State University Graduate Medical Education Public Trust
- 19 Authority who shall be a nonvoting member.
- 20 D. All members shall be appointed by June 1, 2006. Of the
- 21 members of the Authority initially appointed, the member appointed
- 22 by the President Pro Tempore of the Senate shall serve a term of one
- 23 (1) year; the member appointed by the Speaker of the House of

- 11 performance of their duties in accordance with the provisions of the

- 14 H. A quorum of the Authority shall be three (3) voting members.
- 15 Members shall elect a chair and vice chair for the Authority from
- 16 among its members. The chair must be an appointed member of the
- 17 Authority.
- 18 I. The Authority shall be subject to the Open Meeting Act,
- 19 Section 301 et seq. of Title 25 of the Oklahoma Statutes, and the
- 20 Open Records Act, Section 24A.1 et seq. of Title 51 of the Oklahoma
- 21 Statutes, except as otherwise provided by this act. Any information
- 22 submitted to or compiled by the Authority except for budgetary
- 23 information related to appropriations or the appropriations process

- 21 educational programs, professional staffing, administrative
- 22 services, benefit plans, research and other medical activities;
