ENGROSSED SENATE BILL NO. 1289 - By: COATES, GUMM, JOLLEY AND JOHNSON (CONSTANCE) of the Senate and MORGAN, PITTMAN AND KERN of the House.

An Act relating to public health and safety; amending 63 O.S. 2001, Section 1-1950.1, as last amended by Section 12, Chapter 436, O.S.L. 2004 (63 O.S. Supp. 2009, Section 1-1950.1), which relates to criminal history background checks for long-term care facility employees; expanding list of persons who may not be hired or contracted by certain employers; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

- 1 SECTION 1. AMENDATORY 63 O.S. 2001, Section 1-1950.1, as last amended
- 2 by Section 12, Chapter 436, O.S.L. 2004 (63 O.S. Supp. 2009, Section 1-1950.1), is

- 4 Section 1-1950.1 A. For purposes of this section:
- 5 1. "Nurse aide" means any person who provides, for compensation, nursing care or
- 6 health-related services to residents in a nursing facility, a specialized facility, a
- 7 residential care home, continuum of care facility, assisted living center or an adult day
- 8 care center and who is not a licensed health professional. Such term also means any
- 9 person who provides such services to individuals in their own homes as an employee or

3	2. "Employ	er" means any of the following facilities, homes, agencies or programs
4	which are subjec	t to the provision of this section:

8		Act,
9	c.	an adult day care center as such term is defined in the Adult Day Care

13	e.	a continuum of care facility as such term is defined by the Continuum
14		of Care and Assisted Living Act,

18		under the Medicaid State Plan Personal Care Program;
19	3. "Home h	ealth or home care agency" means any person, partnership, association,
20	corporation or ot	her organization which administers, offers or provides health care
21	services or suppo	ortive assistance for compensation to three or more ill, disabled, or infirm

1	persons in the temporary or permanent residence of such persons, and includes any
2	subunits or branch offices of a parent home health or home care agency; and
3	4. "Bureau" means the Oklahoma State Bureau of Investigation.
4	B. 1. Except as otherwise provided by subsection C of this section, before any
5	employer makes an offer to employ or to contract with a nurse aide or other person to
6	provide nursing care, health-related services or supportive assistance to any individual
7	except as provided by paragraph 4 of this subsection, the employer shall provide for a
8	criminal history background check to be made on the nurse aide or other person
9	pursuant to the provisions of this section. If the employer is a facility, home or
10	institution which is part of a larger complex of buildings, the requirement of a criminal
11	history background check shall apply only to an offer of employment or contract made to
12	a person who will work primarily in the immediate boundaries of the facility, home or
13	institution.
14	2. Except as otherwise specified by subsection D of this section, an employer is
15	authorized to obtain any criminal history background records maintained by the
16	Oklahoma State Bureau of Investigation which the employer is required or authorized to
17	request by the provisions of this section.
18	3. The employer shall request the Bureau to conduct a criminal history background
19	check on the person and shall provide to the Bureau any relevant information required
20	by the Bureau to conduct the check. The employer shall pay a fee of Fifteen Dollars
21	(\$15.00) to the Bureau for each criminal history background check that is conducted
22	nursuant to such a request

1	j. an individual who is to be employed by a nursing service conducted by
2	and for the adherents of any religious denomination, the tenets of
3	which include reliance on spiritual means through prayer alone for
4	healing.
5	5. At the request of an employer, the Bureau shall conduct a criminal history
6	background check on any person employed by the employer, including the persons
7	specified in paragraph 4 of this subsection at any time during the period of employment
8	of such person.
9	C. 1. An employer may make an offer of temporary employment to a nurse aide or
10	other person pending the results of the criminal history background check on the person.
11	The employer in such instance shall provide to the Bureau the name and relevant
12	information relating to the person within seventy-two (72) hours after the date the
13	person accepts temporary employment. The employer shall not hire or contract with a
14	person on a permanent basis until the results of the criminal history background check
15	are received.
16	2. An employer may accept a criminal history background report less than one (1)
17	year old of a person to whom such employer makes an offer of employment or
18	employment contract. The report shall be obtained from the previous employer or
19	contractor of such person and shall only be obtained upon the written consent of such
20	person.

1	D. 1. The Bureau shall not provide to the employer the criminal history	
2	background records of a person being investigated pursuant to this section unless the	
3	criminal records relate to:	
4	a. any felony or misdemeanor classified as a crime against the person,	
5	b. any felony or misdemeanor classified as a crime against public decency	
6	or morality,	
7	c. any felony or misdemeanor classified as domestic abuse pursuant to	
8	the provisions of the Protection from Domestic Abuse Act,	
9	d. a felony violation of any state statute intended to control the	
10	possession or distribution of a Schedule I through V drug pursuant to	
11	the Uniform Controlled Dangerous Substances Act, and	
12	e. any felony or misdemeanor classified as a crime against property.	
13	2. Within five (5) days of receiving a request to conduct a criminal history	
14	background check, the Bureau shall complete the criminal history background check an	
15	report the results of the check to the requesting employer.	
16	E. Every employer who is subject to the provisions of this section shall inform each	
17	applicant for employment, or each prospective contract provider, as applicable, that the	
18	employer is required to obtain a criminal history background record before making an	
19	offer of permanent employment or contract to a nurse aide or other person described in	
20	subsection B of this section.

2	2. If the results of a criminal history background check reveal that an employee or
3	a person hired on a temporary basis pursuant to subsection C of this section or any other
4	person who is an employee or contract provider has been convicted of any of the offenses
5	listed in paragraph 1 of this subsection, the employer shall immediately terminate the
6	person's employment or contract. The provisions of this paragraph shall not apply to an
7	employee or contract provider of an employer who has completed the requirements for
8	certification and placement on the nurse aide registry and who has been continuously
9	employed by the employer prior to January 1, 1992.
10	G. An employer shall not employ or continue employing a person addicted to any
11	Schedule I through V drug as specified by the Uniform Controlled Dangerous Substance
12	Act unless the person produces evidence that the person has successfully completed a
13	drug rehabilitation program.
14	H. All criminal records received by the employer are confidential and are for the
15	exclusive use of the State Department of Health and the employer which requested the
16	information. Except on court order or with the written consent of the person being
17	investigated, the records shall not be released or otherwise disclosed to any other person
18	or agency. These records shall be destroyed after one (1) year from the end of
19	employment of the person to whom such records relate.
20	I. Any person releasing or disclosing any information received pursuant to this
21	section without the authorization prescribed by this section shall be guilty of a

1	J. As part of the inspections required by the Nursing Home Care Act, Continuum of
2	Care and Assisted Living Act, the Residential Care Act, and the Adult Day Care Act, the
3	State Department of Health shall review the employment files of any facility, home or
4	institution required to obtain criminal history background records to ensure such
5	facilities, homes or institutions are in compliance with the provisions of this section.
6	SECTION 2. This act shall become effective November 1, 2010.
