"Person" means and includes any individual, company, partnership, joint venture, joint agreement, association (mutual or otherwise), limited liability company, corporation, estate, trust, business trust receiver, or trustee appointed by any state or federal court, or otherwise, syndicate, or any political subdivision of the state or combination acting as a unit;
 - 5. "Retailer" means:
 - a. a person who comes into the possession of cigarettes for the purpose of selling, or who sells them at retail, or
 - b. a person, not coming within the classification of wholesaler, or distributor having possession of more than one thousand cigarettes; and
- 6. "Wholesaler" means a person, firm, or corporation organized and existing, or doing business, primarily to sell cigarettes, including electronic cigarettes, and render service to retailers in the state.
