11 AMENDMENT NO. 1. Delete the stricken title, enacting clause and  
12 entire bill and replace with:

13 "An Act relating to teacher certification; defining  
14 terms; directing State Board of Education initiate  
15 certain pilot project; providing for applications  
16 process; specifying criteria for provider  
17 participation; requiring State Board of Education to  
18 ensure that providers make certain allowances;  
19 authorizing suspension or approval revocation of  
20 providers under certain instances; requiring certain  
21 notice and opportunities; providing eligibility for  
22 certification under certain conditions; requiring  
23 the certificate issuance under certain conditions;  
24 assigning responsibility for criminal history record  
check costs; requiring certain report; requiring  
reports include certain information; requiring the  
annual submission of certain evidence; authorizing  
the promulgation of rules; requiring pilot program  
end by certain date; and providing for codification.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1           SECTION 1.           NEW LAW           A new section of law to be codified  
2 in the Oklahoma Statutes as Section 6-133 of Title 70, unless there  
3 is created a duplication in numbering, reads as follows:

4           A. As used in this section:

5           1. "Provider" means an eligible entity that seeks or has  
6 obtained approval of an alternative teacher preparation program  
7 consistent with this section; and

8           2. "Program" means content provided by a provider that leads  
9 toward licensure in a specific content area.

10          B. The State Board of Education shall identify providers to  
11 implement new and innovative pathways toward teacher certification  
12 on a pilot program basis. Providers seeking to participate in the  
13 pilot program shall submit applications to the State Board of  
14 Education.

15          C. A provider chosen by the State Board of Education to  
16 participate in the pilot program shall offer a program that:

17           1. Provides evidence and history of fiscal solvency, capacity,  
18 operation and program effectiveness;

19           2. Provides evidence of necessary infrastructure to provide  
20 accurate, timely and secure data for the purpose of admission,  
21 teacher candidate monitoring, testing and certification  
22 recommendations;

23           3. Has policies and procedures in place ensuring the security  
24 of teacher candidate records under applicable laws and regulations;

1           4. Has the instructional capacity or ability to obtain the  
2 instructional capacity to provide adequate instruction in accordance  
3 with this subsection;

4           5. Offers an instructional phase that provides intensive  
5 preparation before the teacher candidates assume classroom  
6 responsibilities;

7           6. Offers a research-based and results-oriented approach  
8 focused on best teaching practices to increase student achievement  
9 and growth measured against state academic standards;

10          7. Provides assessment, supervision and evaluation of teacher  
11 candidates to determine their specific needs throughout the program  
12 and to support efforts to successfully complete the program;

13          8. Provides intensive and ongoing professional development  
14 opportunities that accelerate a teacher candidate's professional  
15 growth, support student learning and provide a workplace  
16 orientation, professional staff development and mentoring;

17          9. Offers peer review focused on standards of professional  
18 practice and continuous professional growth; and

19          10. Provides a process to review a teacher candidate's final  
20 competency of required certification content standards that leads to  
21 a potential candidate being recommended for teacher certification in  
22 accordance with subsection F of this section.

23          D. The State Board of Education shall ensure that providers  
24 approved to participate in the pilot program allow teacher

1 candidates to demonstrate pedagogy and content standard proficiency  
2 in school-based programs and through other nontraditional means.  
3 Nontraditional means may include but not be limited to previous work  
4 experience, teacher experience, educator evaluations, industry-  
5 recognized certifications and other essentially equivalent  
6 demonstrations.

7 E. If the State Board of Education determines that a provider  
8 fails to meet or is deficient in any of the requirements of this  
9 section, it may suspend or revoke the approval of the provider after  
10 providing notification of the deficiencies and an opportunity to  
11 remedy the deficiencies.

12 F. A teacher candidate that completes a program offered by an  
13 approved provider shall be eligible for certification, provided he  
14 or she meets the certification requirements set forth in Section 6-  
15 187 of Title 70 of the Oklahoma Statutes in the area of  
16 specialization for which certification is sought and is recommended  
17 for certification by the approved provider.

18 G. The State Board of Education shall issue a certificate to  
19 teach to any person who meets the requirements set forth in this  
20 section and who has on file with the Board a current Oklahoma  
21 criminal history record check from the Oklahoma State Bureau of  
22 Investigation as well as a national criminal history record check as  
23 defined in Section 150.9 of Title 74 of the Oklahoma Statutes. The

1 187 of Title 70 of the Oklahoma Statutes in the area of  
2 specialization for which certification is sought and is recommended  
3 for certification by the approved provider.

4 G. The State Board of Education shall issue a certificate to  
5 teach to any person who meets the requirements set forth in this  
6 section and who has on file with the Board a current Oklahoma  
7 criminal history record check from the Oklahoma State Bureau of  
8 Investigation as well as a national criminal history record check as  
9 defined in Section 150.9 of Title 74 of the Oklahoma Statutes. The  
10 person applying for the certificate shall be responsible for the  
11 cost of the criminal history records.

12 H. A provider shall submit a report to the State Department of  
13 Education after one year of operation showing the percentage of  
14 teacher candidates who have completed the program and who have  
15 successfully completed or who have failed the competency  
16 examinations for certification and the provider's efforts to help  
17 candidates successfully pass the examinations. A provider shall  
18 annually submit evidence to the State Department of Education after  
19 the pilot year with evidence of the success of the program.

20 I. The State Board of Education may promulgate rules to  
21 implement the provisions of this section.

22 ~~SECTION 3. This act shall become effective July 1, 2019.~~

23 ~~SECTION 4. It being immediately necessary for the preservation~~  
24 ~~of the public peace, health or safety, an emergency is hereby~~

1 ~~declared to exist, by reason whereof this act shall take effect and~~  
2 ~~be in full force from and after its passage and approval.~~
