12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 68 O.S. 2011, Section 4307, as
14 amended by Section 5, Chapter 3, O.S.L. 2014 (68 O.S. Supp. 2018,
15 Section 4307), is amended to read as follows:

16 Section 4307. Notwithstanding any other provision of this act,
17 total payments resulting from the provisions of the Oklahoma Quality
18 Events Incentive Act to all host communities shall not exceed:

19 1. Two Million Dollars (\$2,000,000.00) for the fiscal year
20 ending June 30, 2013;

21 2. Two Million Five Hundred Thousand Dollars (\$2,500,000.00)
22 for the fiscal year ending June 30, 2014; and

23 3. Three Million Dollars (\$3,000,000.00) for each of the fiscal
24 years ending June 30, 2015, through ~~June 30, 2018~~ June 30, 2021.

SECTION 2. This act shall become effective November 1, 2019.
