11 AMENDMENT NO. 1. Delete the stricken title, enacting clause and
12 entire bill and replace with:

13
14 "An Act relating to school accreditation; amending 70
15 O.S. 2011, Section 3-104.4, as last amended by
16 Section 27, Chapter 42, O.S.L. 2017 (70 O.S. Supp.
17 2018, Section 3-104.4), which relates to standards
18 for school accreditation; removing previous dates;
19 updating citations; modifying accreditation
20 standards; directing standards to provide for
21 warnings, probation or nonaccredited status for
22 certain schools; modifying specified time for State
23 Department of Education to investigate complaints;
24 altering time for Department to report investigation
findings to State Board of Education; specifying
when Board shall withdraw accreditation for school;
directing regulations to provide for warnings and
assistance to certain schools; directing school
evaluations for accreditation standards to take
place once every four years beginning in certain
school year; providing exceptions; requiring annual
school evaluation for certain listed criteria;
mandating annual evaluations for schools receiving a
deficiency; providing an exception; amending 70 O.S.

1 2011, Section 3-154, which relates to review of
2 certain school plans; updating statutory references;
3 requiring review to take place in accordance with
4 certain schedule; and providing an effective date.

5 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

6 SECTION 1. AMENDATORY 70 O.S. 2011, Section 3-104.4, as
7 last amended by Section 27, Chapter 42, O.S.L. 2017 (70 O.S. Supp.
8 2018, Section 3-104.4), is amended to read as follows:

9 Section 3-104.4 A. ~~On or before February 1, 1991, the~~ The
10 State Board of Education shall adopt standards for the accreditation
11 of the public schools in this state according to the requirements of
12 ~~this act~~ Section 3-104.3 et seq. of this title, to be effective as
13 set forth in ~~this act~~ Section 3-104.3 et seq. of this title. The
14 accreditation standards shall incorporate the curricular standards
15 established pursuant to Section 11-103.6 of this title. The
16 accreditation standards shall equal or exceed ~~the accreditation~~
17 ~~standards for schools promulgated by the North Central Association~~
18 ~~of Colleges and Schools~~ nationally recognized accreditation
19 standards to the extent that the standards are consistent with an
20 academic results oriented approach to accreditation, ~~excluding those~~
21 ~~standards which deal with affective behavior to the extent the~~
22 ~~adoption of the standards does not conflict with state statute.~~ The
23 accreditation adopted by the State Board shall encompass
24 accreditation for elementary schools, middle schools, junior high

1 schools, and high schools. The accreditation standards shall be
2 made available for public inspection at the offices of the State
3 Department of Education.

4 B. Standards for accreditation adopted by the State Board of
5 Education shall include standards relating to the provision of
6 school counselors to the public school children of this state. The
7 State Board of Education shall require each local school district to
8 provide information regarding the number of counselors serving each
9 school site, the duties of all such counselors including all
10 administrative duties, the number of students served by each
11 counselor, and information regarding the number of counselors
12 employed per elementary school, middle school, junior high school
13 and high school.

14 C. Except as otherwise provided ~~by subsection A of this section~~
15 ~~with regard to curricular standards, as a condition of receiving~~
16 ~~state accreditation pursuant to this act:~~

17 1. ~~High schools shall meet the accreditation standards not~~
18 ~~later than June 30, 1995; and~~

19 2. ~~Elementary, middle and junior high schools shall meet the~~
20 ~~accreditation standards not later than June 30, 1999.~~

21 Schools, schools shall thereafter continue to meet the
22 accreditation standards as a condition of continued accreditation.
23 Nothing herein shall be construed as preventing changes to the
24 adopted standards by the State Board of Education pursuant to the

1 Administrative Procedures Act. The accreditation standards shall
2 provide for warnings, probation or nonaccredited status for schools
3 that fail to meet the standards. The Department shall investigate a
4 complaint of failure to provide educational services or failure to
5 comply with accreditation standards within thirty (30) days of
6 receiving the complaint. If the Department determines that a school
7 has failed to comply with the accreditation standards, the
8 Department shall report the recommended warning, probation or
9 nonaccredited accreditation status to the State Board of Education
10 within ninety (90) days. If a school does not take action to comply
11 with the accreditation standards within ninety (90) days after a
12 report is filed by the Department, the Board shall withdraw
13 accreditation for the school. The State Board accreditation
14 regulations shall provide for warnings and for assistance to schools
15 and school districts whenever there is reason to believe a school is
16 in danger of losing its state accreditation.

17 D. If one or more school sites ~~fails~~ fail to receive
18 accreditation as required pursuant to this section ~~by the dates set~~

13 instructional means meets accreditation standards.

10 determine whether they meet the accreditation standards set forth in
11 accordance with this section shall occur once every four (4) years
12 on a schedule adopted by the State Board of Education. The Board
13 may interrupt the evaluation schedule provided in this subsection
14 for reasons including a change in the superintendent of the school
15 district; determination that one or more school district board
16 members have not met the continuing education requirements as
17 defined by this title; determination that the school district
18 falsified information submitted to any public city, county, state or
19 federal official or agency; initiation of an investigation by the
20 Board or a law enforcement agency; or other determination by the
21 Board that standards for accreditation are not being met by the
22 school district. The schedule adopted by the Board shall allow for
23 school districts receiving no deficiencies for two (2) consecutive
24 years to be reviewed for accreditation less than annually.

1 Provided, however, that schools shall be evaluated annually for the
2 purposes of:

3 1. Local, state and federal funding;

4 2. Health and safety;

5 3. Certification requirements for teachers, principals and
6 superintendents;

7 4. School board governance, including instructional and
8 continuing education requirements for school board members; and

9 5. Any other requirements under state or federal law.

10 J. Beginning with the 2019-2020 school year, if a public school
11 receives a deficiency on its accreditation report, the public school
12 shall be evaluated annually to determine if it meets the
13 accreditation standards set forth in accordance with this section.

14 If the public school receives no deficiencies for two (2)
15 consecutive years, the public school shall be subject to the
16 evaluation timeline established in subsection I of this section.

17 SECTION 2. AMENDATORY 70 O.S. 2011, Section 3-154, is
18 amended to read as follows:

19 Section 3-154. Each plan listed in ~~Section 1 of this act~~
20 Section 3-153 of this title and which is not required to be
21 submitted to the State Department of Education shall be reviewed by
22 a regional accreditation officer at the time of the ~~annual~~ visit to
23 the school district by an officer in accordance with the evaluation
24 schedule set forth in Section 3-104.4 of this title.

12 students to accredited schools within the district or shall annex
13 the district to one or more other districts in which the students
14 can be educated in accredited schools.

16 Education shall include standards relating to the provision of
17 educational services provided in partial hospitalization programs,

8 receives a deficiency on its accreditation report, the public school
9 shall be evaluated annually to determine if they meet the
10 accreditation standards set forth in accordance with this section.

11 If the public school receives no deficiencies for two (2)
12 consecutive years, the public school shall be subject to the
13 evaluation timeline established in subsection K of this section.

14 SECTION 5. AMENDATORY 70 O.S. 2011, Section 3-154, is
15 amended to read as follows:

16 Section 3-154. Each plan listed in ~~Section 1 of this act~~
17 Section 3-153 of this title and which is not required to be
18 submitted to the State Department of Education shall be reviewed by
19 a regional accreditation officer at the time of the ~~annual~~ visit to
20 the school district by an officer in accordance with the evaluation
21 schedule set forth in Section 3-104.4 of this title.

22 ~~SECTION 6. This act shall become effective July 1, 2019.~~

23 ~~SECTION 7. It being immediately necessary for the preservation~~
24 ~~of the public peace, health or safety, an emergency is hereby~~

1 ~~declared to exist, by reason whereof this act shall take effect and~~
2 ~~be in full force from and after its passage and approval.~~
