16	SECTION 1. AMENDATORY 26 O.S. 2011, Section 12-101, as		
17	amended by Section 1, Chapter 3, O.S.L. 2012 (26 O.S. Supp. 2018,		
18	Section 12-101), is amended to read as follows:		
19	Section 12-101. A. Except as otherwise provided by law,		
20	whenever a vacancy shall occur in the office of a member of the		
21	United States Senate or United States House of Representatives from		
22	Oklahoma, such vacancy shall be filled at a Special Election to be		
23	called by the Governor, who shall issue a Writ of Election within		
24	thirty (30) days after such vacancy occurs.

1 B. No special election shall be called if the If such a vacancy 2 occurs in an even-numbered year if the term of the office expires 3 the following year. In such case, the candidate elected to the 4 office at the regular General Election shall be appointed by the 5 Covernor to fill the unexpired term, the Regular Primary Election, 6 Runoff Primary Election or General Election for that office shall be 7 deemed to also serve as a Special Election to fill the unexpired 8 term as designated by the Governor. Within thirty (30) days after 9 such vacancy occurs, the Governor shall issue a Writ of Election 10 declaring the same, and the candidate elected at the Regular 11 Election shall be deemed to have also been elected at a Special 12 Election to fill the unexpired term. 13

- C. The proclamation required by Section 12-102 of this title shall serve as the Writ of Election described in this section.
- SECTION 2. AMENDATORY 26 O.S. 2011, Section 12-103, as amended by Section 2, Chapter 3, O.S.L. 2012 (26 O.S. Supp. 2018, Section 12-103), is amended to read as follows:

Section 12-103. The proclamation required by Section 12-102 of this title shall prescribe filing and election dates that permit full compliance with the requirements of the federal Military and Overseas Voter Empowerment Act of 2009 and shall contain the following facts:

A filing period of three (3) days, on a Monday, Tuesday and 2 Wednesday not less than ten (10) days from the date of such 3 proclamation; The date of the Special Primary Election, not less than 4 twenty (20) days after the close of the filing period; 5 6 3. The date of the Special Runoff Primary Election, not less 7 than twenty (20) days after the date of the Special Primary Election; and 4. The date of the Special General Election, not less than 10 twenty (20) days after the date of the Special Runoff Primary 11 Election. 12 Should such a vacancy occur in an even-numbered year, when a 13 special election is required, the proclamation must contain dates 14 that are the same as are required by law for the regular filing 15 period, Primary Election, Runoff Primary Election and General 16 Election, if practicable. 17 SECTION 3.
