10 PROPOSED COMMITTEE SUBSTITUTE

11 An Act relating to the Digital Transformation Program
12 Revolving Fund; designating the nature of the fund;
13 declaring fund monies appropriated; providing and
14 limiting purpose of expenditure; requiring certain
15 expenditure and budgetary procedures; requiring
16 certain periodic reporting of certain information to
17 certain individuals; providing for codification; and
18 declaring an emergency.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 36 of Title 62, unless there is
22 created a duplication in numbering, reads as follows:

23 A. There is hereby created in the State Treasury a fund for the
24 Office of Management and Enterprise Services to be designated the
"Digital Transformation Program Revolving Fund". The fund shall be
a continuing fund, not subject to fiscal year limitations, and shall

1 consist of monies designated to the fund by law. All monies
2 accruing to the credit of the fund are hereby appropriated and may
3 be budgeted and expended by the Office of Management and Enterprise
4 Services for the sole purpose of implementing digital transformation
5 initiatives. Expenditures from the fund shall be made upon warrants
6 issued by the State Treasurer against claims filed as prescribed by
7 law with the Director of the Office of Management and Enterprise
8 Services for approval and payment.

9 B. Monthly the Director of the Office of Management and
10 Enterprise Services shall submit reports to the Speaker of the
11 Oklahoma House of Representatives, the President Pro Tempore of the
12 Oklahoma State Senate, the Chair of the Appropriations and Budget
13 Committee of the Oklahoma House of Representatives and the Chair of
14 the Appropriations Committee of the Oklahoma State Senate detailing:

15 1. Expenditures from the Digital Transformation Program
16 Revolving Fund; and

17 2. Projects under consideration for future expenditures from
18 the fund.

19 SECTION 2. It being immediately necessary for the preservation
20 of the public peace, health or safety, an emergency is hereby
21 declared to exist, by reason whereof this act shall take effect and
22 be in full force from and after its passage and approval.
