17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:	
18	SECTION 1. NEW LAW A new section of law to be codified	
19	in the Oklahoma Statutes as Section 36 of Title 62, unless there is	
20	created a duplication in numbering, reads as follows:	
21	A. There is hereby created in the State Treasury a fund for the	
22	Office of Management and Enterprise Services to be designated the	
23	"Digital Transformation Program Revolving Fund". The fund shall be	
24	a continuing fund, not subject to fiscal year limitations, and shall

- consist of monies designated to the fund by law. All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by the Office of Management and Enterprise Services for the sole purpose of implementing digital transformation initiatives. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.
  - B. Monthly the Director of the Office of Management and Enterprise Services shall submit reports to the Speaker of the Oklahoma House of Representatives, the President Pro Tempore of the Oklahoma State Senate, the Chair of the Appropriations and Budget Committee of the Oklahoma House of Representatives and the Chair of the Appropriations Committee of the Oklahoma State Senate detailing:
  - 1. Expenditures from the Digital Transformation Program Revolving Fund; and
  - 2. Projects under consideration for future expenditures from the fund.
- SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
