3. "Disposal" shall mean the final disposition of medical marijuana waste by either a process which renders the waste unusable through physical destruction or a recycling process;

- 4. "Facility" shall mean a location where the disposal of medical marijuana waste takes place by a licensee;
- 5. "License" shall mean a medical marijuana waste disposal license;
- 6. "Licensee" shall mean the holder of a medical marijuana waste disposal license;
 - 7. "Medical marijuana waste" shall mean:
 - a. unused, surplus, returned or out-of-date marijuana and plant debris of the plant of the genus Cannabis, including dead plants and all unused plant parts, except the term shall not include roots, stems, stalks and fan leaves,
 - b. all product which is deemed to fail laboratory testing, and
 - all product and inventory from commercial licensees,
 medical marijuana research facilities and medical
 marijuana education facilities that have gone out of
 business and are not subject to the provisions of
 Section 1560 of Title 12 of the Oklahoma Statutes; and
