11 An Act relating to prisons and reformatories;  
12 granting wage increase to personnel of Department of  
13 Corrections in certain job classifications; providing  
14 limitations; providing for codification; providing an  
15 effective date; and declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. NEW LAW A new section of law to be codified  
18 in the Oklahoma Statutes as Section 528.7 of Title 57, unless there  
19 is created a duplication in numbering, reads as follows:

20 Effective July 1, 2019, all personnel of the Department of  
21 Corrections in the following job classifications who were employed  
22 by the state on the last working day of June 2019 shall be awarded  
23 an increase of Two Dollars (\$2.00) per hour over their current  
24

1 hourly wage, or an equivalent amount if not receiving an hourly  
2 wage:

- 4 2. Construction/Maintenance Administrator;
- 5 3. Construction/Maintenance Technician;
- 6 4. Correctional Case Manager;
- 7 5. Correctional Chief of Security;
- 8 6. Correctional Records Officer;
- 9 7. Correctional Security Manager;
- 10 8. Correctional Security Officer;
- 11 9. Correctional Unit Assistant;
- 12 10. Customer Service Representative;
- 13 11. Food Service Manager;
- 14 12. Food Service Specialist;
- 15 13. Linen and Clothing Specialist;
- 16 14. Materiel Management Officer;
- 17 15. Materiel Management Specialist;
- 18 16. Unit Manager (DOC);
- 19 17. Advanced Practice Nurse;
- 20 18. Clinical Coordinator;
- 21 19. Correctional Health Service Administrator I;
- 22 20. Correctional Health Service Administrator II;
- 23 21. Correctional Health Service Administrator III;
- 24 22. Correctional Health Service Administrator IV;

- 1 23. Dental Care Assistant;
- 2 24. Dental Hygienist;
- 3 25. Dentist;
- 4 26. Health Information Technician;
- 5 27. Laboratory Technician;
- 6 28. Lead Psychiatrist;
- 7 29. Lead Staff Physician II;
- 8 30. Licensed Clinical Social Worker;
- 9 31. Licensed Practical Nurse;
- 10 32. Nursing Manager;
- 11 33. Optometrist;
- 12 34. Patient Care Assistant;
- 13 35. Psychiatrist;
- 14 36. Psychological Clinician;
- 15 37. Psychologist;
- 16 38. Regional Supervising Physician;
- 17 39. Registered Nurse;
- 18 40. Social Services Specialist; and
- 19 41. Staff Physician.

20 SECTION 2. This act shall become effective July 1, 2019.

21 SECTION 3. It being immediately necessary for the preservation  
22 of the public peace, health or safety, an emergency is hereby  
23

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
