10 COMMITTEE SUBSTITUTE

11 An Act relating to the State Department of Health;
12 requiring that portions of certain appropriated funds
13 be used for certain purposes; stating purpose of
14 certain disbursement; requiring the use of certain
15 data; directing the Department to develop method of
16 disbursement; authorizing promulgation of rules;
17 authorizing requests for early transfers of certain
18 funds for specific purposes; providing for lapse of
19 funds under certain conditions; requiring certain
20 budget procedures; prohibiting certain budget
21 procedures; providing an effective date; and
22 declaring an emergency.

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24 SECTION 1. From the funds appropriated to the State Department
of Health in Enrolled House Bill No. 2765 of the 1st Session of the
57th Oklahoma Legislature, the sum of Seven Hundred Eighty Thousand
Dollars (\$780,000.00) shall be used to enhance funding at county
health departments.

1 SECTION 2. From the funds appropriated to the State Department
2 of Health in Enrolled House Bill No. 2765 of the 1st Session of the
3 57th Oklahoma Legislature, the sum of Seven Hundred Fifty-eight
4 Thousand Two Hundred Forty-seven Dollars (\$758,247.00) shall be used
5 to increase child immunization rates in Oklahoma.

6 SECTION 3. From the funds appropriated to the State Department
7 of Health in Enrolled House Bill No. 2765 of the 1st Session of the
8 57th Oklahoma Legislature, the sum of Two Million Dollars
9 (\$2,000,000.00) shall be used for the implementation of the Choosing
10 Childbirth Act by the provisions listed in Section 1-740.15 et seq.
11 of Title 63 of the Oklahoma Statutes.

12 SECTION 4. From the funds appropriated to the State Department
13 of Health in Enrolled House Bill No. 2765 of the 1st Session of the
14 57th Oklahoma Legislature, the sum of Two Hundred Sixty Thousand
15 Dollars (\$260,000.00) shall be used for the Childhood Lead Screening
16 Program.

17 SECTION 5. From the funds appropriated to the State Department
18 of Health in Enrolled House Bill No. 2765 of the 1st Session of the
19 57th Oklahoma Legislature, the sum of Eight Hundred Thirty Thousand
20 Dollars (\$830,000.00) shall be used for Infectious Disease
21 Prevention.

22 SECTION 6. From the funds appropriated to the State Department
23 of Health in Enrolled House Bill No. 2765 of the 1st Session of the
24 57th Oklahoma Legislature, the sum of One Hundred Thousand Dollars

1 (\$100,000.00) shall be used for the operations of the Oklahoma
2 Athletic Commission, pursuant to the provisions of the Oklahoma
3 State Athletic Commission Act.

4 SECTION 7. From the funds appropriated to the State Department
5 of Health in Enrolled House Bill No. 2765 of the 1st Session of the
6 57th Oklahoma Legislature, One Million Nine Hundred Thousand Dollars
7 (\$1,900,000.00) shall be disbursed to health centers authorized
8 under Section 330 of the Public Health Services Act, and
9 incorporated in the State of Oklahoma. Any disbursement shall be
10 for the purpose of increasing access to primary health care which
11 may include medical, dental, and or mental health and substance
12 abuse treatment services in or near designated Medically Underserved
13 Areas or Medically Underserved Populations. Any disbursement for
14 increased access to primary health care services shall be supported
15 by data according to proportions of patient volume and access for
16 uninsured. The method of disbursement shall be developed by the
17 State Department of Health. The State Commissioner of Health is
18 authorized to promulgate the method of disbursement into rules.

19 SECTION 8. The Commissioner of the State Department of Health
20 may request through the Director of the Office of Management and
21 Enterprise Services the early transfer by the Oklahoma Tax
22 Commission of tax collections to the General Revenue Fund for the
23 purpose of early allocation to the Department's disbursing funds to
24 alleviate cash-flow problems.

1 SECTION 9. Appropriations made by Enrolled House Bill No. 2765
2 of the 1st Session of the 57th Oklahoma Legislature, not including
3 appropriations made for capital outlay purposes, may be budgeted for
4 the fiscal year ending June 30, 2020 (hereafter FY-20), or may be
5 budgeted for the fiscal year ending June 30, 2021 (hereafter FY-21).
6 Funds budgeted for FY-20 may be encumbered only through June 30,
7 2020, and must be expended by November 15, 2020. Any funds
8 remaining after November 15, 2020, and not budgeted for FY-21, shall
9 lapse to the credit of the proper fund for the then-current fiscal
10 year. Funds budgeted for FY-21 may be encumbered only through June
11 30, 2021. Any funds remaining after November 15, 2021, shall lapse
12 to the credit of the proper fund for the then-current fiscal year.
13 These appropriations shall not be budgeted in both fiscal years
14 simultaneously. Funds budgeted in FY-20, and not required to pay
15 obligations for that fiscal year, may be budgeted for FY-21, after
16 the agency to which the funds have been appropriated has prepared
17 and submitted a budget work program revision removing these funds
18 from the FY-20 budget work program and after such revision has been
19 approved by the Office of Management and Enterprise Services.

20 SECTION 10. This act shall become effective July 1, 2019.

21 SECTION 11. It being immediately necessary for the preservation
22 of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
