11 An Act relating to the Oklahoma Department of
12 Agriculture, Food, and Forestry; requiring that
13 portions of certain appropriated funds be used for
14 certain purposes; providing an effective date; and
15 declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. From the funds appropriated to the Oklahoma
18 Department of Agriculture, Food, and Forestry in Enrolled House Bill
19 No. 2765 of the 1st Session of the 57th Oklahoma Legislature, not
20 less than Two Hundred Thousand Dollars (\$200,000.00) shall be used
21 to provide for wildfire suppression activities. These funds shall
22 be used to provide additional wildfire suppression activities and
23 shall be used to supplement rather than replace existing resources.

1 SECTION 2. From the funds appropriated to the Oklahoma
2 Department of Agriculture, Food, and Forestry in Enrolled House Bill
3 No. 2765 of the 1st Session of the 57th Oklahoma Legislature, the
4 sum of Five Hundred Thousand Dollars (\$500,000.00) shall be
5 transferred to the Healthy Food Financing Revolving Fund created by
6 Section 5-204 of Title 2 of the Oklahoma Statutes.

7 SECTION 3. From the funds appropriated to the Oklahoma
8 Department of Agriculture, Food, and Forestry in Enrolled House Bill
9 No. 2765 of the 1st Session of the 57th Oklahoma Legislature, not
10 less than Five Hundred Thousand Dollars (\$500,000.00) shall be used
11 to provide for feral swine control. These funds shall be used to
12 provide additional feral swine control activities and shall be used
13 to supplement rather than replace existing resources.

14 SECTION 4. From the funds appropriated to the Oklahoma
15 Department of Agriculture, Food, and Forestry in Enrolled House Bill
16 No. 2765 of the 1st Session of the 57th Oklahoma Legislature, not
17 less than Ninety Thousand Dollars (\$90,000.00) shall be used to
18 provide for veterinarian staff positions. These funds shall be used
19 to provide additional veterinarian staff positions and shall be used
20 to supplement rather than replace existing resources.

21 SECTION 5. From the funds appropriated to the Oklahoma
22 Department of Agriculture, Food, and Forestry in Enrolled House Bill
23 No. 2765 of the 1st Session of the 57th Oklahoma Legislature, not
24 less than Five Hundred Thousand Dollars (\$500,000.00) shall be used

1 to provide for laboratory equipment. These funds shall be used to
2 provide additional laboratory equipment or upgrades to existing
3 equipment and shall be used to supplement rather than replace
4 existing resources.

5 SECTION 6. From the funds appropriated to the Oklahoma
6 Department of Agriculture, Food, and Forestry in Enrolled House Bill
7 No. 2765 of the 1st Session of the 57th Oklahoma Legislature, not
8 less than Six Hundred Thousand Dollars (\$600,000.00) shall be used
9 to provide for rural fire operational assistance grants. These
10 funds shall be used to provide additional rural fire operational
11 assistance grants and shall be used to supplement rather than
12 replace existing resources.

13 SECTION 7. This act shall become effective July 1, 2019.

14 SECTION 8. It being immediately necessary for the preservation
15 of the public peace, health or safety, an emergency is hereby
16 declared to exist, by reason whereof this act shall take effect and
17 be in full force from and after its passage and approval.
