- B. The State Department of Education shall provide assistance to school districts in calculating the amounts described in subsection A of this section and a schedule of payments.
- C. Payments made to a receiving school district pursuant to subsection A of this section shall be included in the receiving school district's calculation of State Aid pursuant to Section 18-200.1 of Title 70 of the Oklahoma Statutes.
- D. The State Board of Education shall promulgate rules necessary to implement the provisions of this act.
