COMMITTEE SUBSTITUTE

An Act relating to school districts; directing an elementary school district or independent district to make certain payment to certain receiving school district to which a student transfers; providing for calculation of payment; directing the State Department of Education to provide certain assistance; directing that certain payment be included in certain school district's State Aid calculation; providing for promulgation of rules; providing for codification; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 5-103.2 of Title 70, unless there is created a duplication in numbering, reads as follows:

A. For each student who transfers from an elementary school district, which is the resident district of the student, to an independent district to attend a grade the student is entitled to pursue pursuant to Section 8-101 of Title 70 of the Oklahoma Statutes, and for each student who transfers from an independent

2 elementary school district, the sending school district shall  
3 provide to the receiving school district a proportional amount of  
4 monies derived from the proceeds of the school levies made pursuant  
5 to the provisions of:

6 1. Subsection (a) of Section 9 of Article X of the Oklahoma  
7 Constitution;

8 2. Subsection (b) of Section 9 of Article X of the Oklahoma  
9 Constitution;

10 3. Subsection (c) of Section 9 of Article X of the Oklahoma  
11 Constitution;

12 4. Subsection (d) of Section 9 of Article X of the Oklahoma  
13 Constitution; and

14 5. Subsection (d-1) of Section 9 of Article X of the Oklahoma  
15 Constitution.

16 B. The State Department of Education shall provide assistance  
17 to school districts in calculating the amounts described in  
18 subsection A of this section and a schedule of payments.

19 C. Payments made to a receiving school district pursuant to  
20 subsection A of this section shall be included in the receiving  
21 school district's calculation of State Aid pursuant to Section 18-  
22 200.1 of Title 70 of the Oklahoma Statutes.

23 D. The State Board of Education shall promulgate rules  
24 necessary to implement the provisions of this act.

1       SECTION 2.   This act shall become effective July 1, 2019.

2       SECTION 3.   It being immediately necessary for the preservation  
3 of the public peace, health or safety, an emergency is hereby  
4 declared to exist, by reason whereof this act shall take effect and  
5 be in full force from and after its passage and approval.
