L5	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
L 6	SECTION 1. AMENDATORY 29 O.S. 2011, Section 3-303, is
L7	amended to read as follows:
18	Section 3-303. A. The Commission may acquire, by purchase,
L 9	gift, grants, grant-in-aid from the federal government, or from any
20	other source public or private, all property or money necessary,
21	useful or convenient for its use in carrying out the objects and
22	purposes of this Code.
23	B. Any and all gifts, grants, royalties and rentals received by
24	the Commission shall, however, be allocated and used in the same

- manner as Wildlife Conservation Funds, except that gifts given for specified purposes by the donor shall be used for such specified purposes.
- C. On any land acquired by the Oklahoma Wildlife Conservation 4 5 Commission pursuant to the provisions of the Oklahoma Wildlife Conservation Code, after the effective date of this act January 1, 6 7 1989, the Commission shall annually make in lieu of tax payments. For land acquired before November 1, 2019, the payments shall be 8 9 equal to the average ad valorem tax per acre paid on similar land in 10 that county. Said For land acquired on or after November 1, 2019, in lieu of tax payments shall be equal to the amount of ad valorem 11 12 tax which would otherwise be levied pursuant to the valuation methodology provided for in subsection C of Section 2817 of Title 68 13 of the Oklahoma Statutes. The payments shall be made from any funds 14 created in or pursuant to the authority granted by the Oklahoma 15 Wildlife Conservation Code. The payments shall be made by the 16 Commission within sixty (60) days from receipt of an itemized 17 statement from the county treasurer of the county in which the land 18 is located. 19
 - D. The provisions of subsection C of this section shall be applicable to any lands acquired by or on behalf of the Oklahoma Wildlife Conservation Commission pursuant to Section 5 of this act Section 168.9 of Title 73 of the Oklahoma Statutes and the Oklahoma Capitol Improvement Authority may enter into such agreements with
