7 An Act relating to prisons and reformatories;
8 granting wage increase to personnel of Department of
9 Corrections in certain job classifications; providing
10 limitations; providing for codification; providing an
11 effective date; and declaring an emergency.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 528.7 of Title 57, unless there
15 is created a duplication in numbering, reads as follows:

16 Effective July 1, 2019, all personnel of the Department of
17 Corrections in the following job classifications who were employed
18 by the state on the last working day of June 2019 shall be awarded
19 an increase of Two Dollars (\$2.00) per hour over their current
20 hourly wage, or an equivalent amount if not receiving an hourly
21 wage:

- 22 1. Chief of Security;
- 23 2. Construction/Maintenance Administrator;
- 24 3. Construction/Maintenance Technician;

- 1 4. Correctional Case Manager;
- 2 5. Correctional Chief of Security;
- 3 6. Correctional Records Officer;
- 4 7. Correctional Security Manager;
- 5 8. Correctional Security Officer;
- 6 9. Correctional Unit Assistant;
- 7 10. Customer Service Representative;
- 8 11. Food Service Manager;
- 9 12. Food Service Specialist;
- 10 13. Linen and Clothing Specialist;
- 11 14. Materiel Management Officer;
- 12 15. Materiel Management Specialist;
- 13 16. Unit Manager (DOC);
- 14 17. Advanced Practice Nurse;
- 15 18. Clinical Coordinator;
- 16 19. Correctional Health Service Administrator I;
- 17 20. Correctional Health Service Administrator II;
- 18 21. Correctional Health Service Administrator III;
- 19 22. Correctional Health Service Administrator IV;
- 20 23. Dental Care Assistant;
- 21 24. Dental Hygienist;
- 22 25. Dentist;
- 23 26. Health Information Technician;
- 24 27. Laboratory Technician;

- 1 28. Lead Psychiatrist;
- 2 29. Lead Staff Physician II;
- 3 30. Licensed Clinical Social Worker;
- 4 31. Licensed Practical Nurse;
- 5 32. Nursing Manager;
- 6 33. Optometrist;
- 7 34. Patient Care Assistant;
- 8 35. Psychiatrist;
- 9 36. Psychological Clinician;
- 10 37. Psychologist;

- 14 41. Staff Physician.

15 SECTION 2. This act shall become effective July 1, 2019.

16 SECTION 3. It being immediately necessary for the preservation
17 of the public peace, health or safety, an emergency is hereby
18 declared to exist, by reason whereof this act shall take effect and
19 be in full force from and after its passage and approval.
