7 An Act relating to the Department of Public Safety;
8 providing certain authorizations; requiring that
9 portions of certain appropriated funds be used for
10 certain purposes; authorizing requests for early
11 transfers of certain funds for specific purposes;
12 providing for lapse of funds under certain
13 conditions; requiring certain budget procedures;
14 prohibiting certain budget procedures; providing an
15 effective date; and declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. Pursuant to Section 2-105.2 of Title 47 of the
18 Oklahoma Statutes, the Department of Public Safety is hereby
19 authorized to conduct up to two Oklahoma Highway Patrol Academies.

20 SECTION 2. The Department of Public Safety is hereby authorized
21 to use the proceeds of the sale of aircraft for the purpose
22 referenced in Section 1 of this act.

23 SECTION 3. From the funds appropriated to the Department of
24 Public Safety in Enrolled House Bill No. 2765 of the 1st Session of
the 57th Oklahoma Legislature, a sum of not less than Four Million

1 Dollars (\$4,000,000.00) shall be used for the purpose referenced in
2 Section 1 of this act.

3 SECTION 4. From the funds appropriated to the Department of
4 Public Safety in Enrolled House Bill No. 2765 of the 1st Session of
5 the 57th Oklahoma Legislature, the sum of One Million Dollars
6 (\$1,000,000.00) shall be used for a communications system.

7 SECTION 5. From the funds appropriated to the Department of
8 Public Safety in Enrolled House Bill No. 2765 of the 1st Session of
9 the 57th Oklahoma Legislature, the sum of Six Hundred Thousand
10 Dollars (\$600,000.00) shall be used for a REAL ID compliant point-
11 of-sale system.

12 SECTION 6. The Commissioner of Public Safety may request
13 through the Director of the Office of Management and Enterprise
14 Services the early transfer by the Oklahoma Tax Commission of tax
15 collections to the General Revenue Fund for the purpose of early
16 allocation to the Department's disbursing funds to alleviate cash-
17 flow problems.

18 SECTION 7. Appropriations made by Enrolled House Bill No. 2765
19 of the 1st Session of the 57th Oklahoma Legislature, not including
20 appropriations made for capital outlay purposes, may be budgeted for
21 the fiscal year ending June 30, 2020 (hereafter FY-20), or may be
22 budgeted for the fiscal year ending June 30, 2021 (hereafter FY-21).
23 Funds budgeted for FY-20 may be encumbered only through June 30,
24 2020, and must be expended by November 15, 2020. Any funds

1 remaining after November 15, 2020, and not budgeted for FY-21, shall
2 lapse to the credit of the proper fund for the then-current fiscal
3 year. Funds budgeted for FY-21 may be encumbered only through June
4 30, 2021. Any funds remaining after November 15, 2021, shall lapse
5 to the credit of the proper fund for the then-current fiscal year.
6 These appropriations shall not be budgeted in both fiscal years
7 simultaneously. Funds budgeted in FY-20, and not required to pay
8 obligations for that fiscal year, may be budgeted for FY-21, after
9 the agency to which the funds have been appropriated has prepared
10 and submitted a budget work program revision removing these funds
11 from the FY-20 budget work program and after such revision has been
12 approved by the Office of Management and Enterprise Services.

13 SECTION 8. This act shall become effective July 1, 2019.

14 SECTION 9. It being immediately necessary for the preservation
15 of the public peace, health or safety, an emergency is hereby
16 declared to exist, by reason whereof this act shall take effect and
17 be in full force from and after its passage and approval.
