1 "SECTION 2. NEW LAW A new section of law to be codified

2 in the Oklahoma Statutes as Section 2368.32 of Title 68, unless

3 there is created a duplication in numbering, reads as follows:

4 A. Each state individual income tax return form for tax years
5 which begin after December 31, 2018, and each state corporate tax
6 return form for tax years beginning after December 31, 2018, shall
7 contain a provision to allow a donation from a tax refund for the
8 benefit of the Model Successful Future Alumni Act of 2019 pilot
9 program.

10 B. Except as otherwise provided for in this section, all monies
11 generated pursuant to subsection A of this section shall be paid to
12 the State Treasurer by the Oklahoma Tax Commission and placed to the
13 credit of the Successful Future Alumni Revolving Fund created in
14 subsection C of this section.

15 C. There is hereby created in the State Treasury a revolving
16 fund to be designated the "Successful Future Alumni Revolving Fund"
17 and administered by the Department of Human Services. The fund
18 shall be a continuing fund, not subject to fiscal year limitations,
19 and shall consist of all the monies received by the Department of
20 Human Services pursuant to the provisions of subsection A of this
21 section. All monies accruing to the credit of the fund are
22 appropriated and may be budgeted and expended by the Department of
23 Human Services at the beginning of each fiscal year for the purpose
24 of establishing and supporting the Model Successful Future Alumni

1 Act of 2019 pilot program. Expenditures from the fund shall be made
2 upon warrants issued by the State Treasurer against claims filed as
3 prescribed by law with the Director of the Office of Management and
4 Enterprise Services for approval and payment.

5 D. If a taxpayer makes a donation pursuant to subsection A of
6 this section in error, such taxpayer may file a claim for refund at
7 any time within three (3) years from the due date of the tax return.
8 Such claims shall be filed pursuant to the provisions of Section
9 2373 of Title 68 of the Oklahoma Statutes. Prior to the
10 apportionment set forth in this section, an amount equal to the
11 total amount of refunds made pursuant to this subsection during any
12 one (1) year shall be deducted from the total donations received
13 pursuant to this section during the following year and such amount
14 deducted shall be paid to the State Treasurer and placed to the
15 credit of the Income Tax Withholding Refund Account."
