8 FLOOR SUBSTITUTE

9 An Act directing the Secretary of State to refer to
10 the people for their approval or rejection of a
11 proposed amendment to the Oklahoma Constitution by
12 adding a new Section 7A to Article II; providing that
13 no provision of the Constitution secures or protects
14 a right to perform or receive an abortion;
15 prohibiting certain construction of Constitution;
16 defining term; providing ballot title; and directing
17 filing.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. The Secretary of State shall refer to the people for
22 their approval or rejection, as and in the manner provided by law,
23 the following proposed amendment to the Oklahoma Constitution by
24 adding a new Section 7A to Article II to read as follows:

Section 7A. A. Nothing in this Constitution secures or
protects the right to perform or receive an abortion, nor shall any
provision of this Constitution be construed to preclude, invalidate
or in any way limit, a statute that prohibits abortion, regulates

1 abortion or regulates abortion differently from other acts or
2 procedures.

3 B. As used in this section, "abortion" means the use or
4 prescription of any instrument, medicine, drug or other substance or
5 device intentionally to terminate a pregnancy other than to increase
6 the probability of a live birth, to preserve the life or health of
7 the child after live birth, to remove an ectopic pregnancy or to
8 remove an unborn child who died as the result of a spontaneous
9 miscarriage, accidental trauma or a criminal assault on the pregnant
10 female or her unborn child.

11 SECTION 2. The Ballot Title for the proposed Constitutional
12 amendment as set forth in SECTION 1 of this resolution shall be in
13 the following form:

16 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

17 This measure adds a new Section 7A to Article 2 of the Oklahoma
18 Constitution. The proposed Section 7A states that nothing in
19 the Oklahoma Constitution secures or protects the right to
20 perform or receive an abortion. The proposed Section 7A also
21 states that nothing in the Oklahoma Constitution may be read to
22 prevent statutes from being enacted that prohibit abortion,
23 regulate abortion or regulate abortion differently from other
24 acts or procedures. "Abortion" is defined for the purposes of

1 this proposed Section 7A as the use or prescription of any
2 instrument, drug or device intentionally to terminate a
3 pregnancy. The measure exempts from this definition terminating
4 a pregnancy for certain reasons, such as to preserve the life or
5 health of an unborn child, to remove an ectopic pregnancy or to
6 remove an unborn child who died as the result of a spontaneous
7 miscarriage, accidental trauma or a criminal assault on a
8 pregnant woman or her unborn child. This measure concerns only
9 the rights guaranteed by the Oklahoma Constitution. It would
10 not alter any rights guaranteed by the United States
11 Constitution.

16 immediately after the passage of this act, prepare and file one copy
