19	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
20	SECTION 1. AMENDATORY Section 63, Chapter 146, O.S.L.
21	2018, is amended to read as follows:
22	Section 63. There is hereby appropriated to the State
23	Department of Health from any monies not otherwise appropriated from
24	the General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2019, the sum of Fifty-four Million Eight Hundred 2 Seventy-four Thousand Seven Hundred Dollars (\$54,874,700.00) Fifty-3 one Million One Hundred Seventy-four Thousand Seven Hundred Dollars 4 (\$51,174,700.00) or so much thereof as may be necessary to perform 5 the duties imposed upon the State Department of Health by law. 6 SECTION 2. An amount of Nine Million Three Hundred Fifty-seven 7 Thousand Two Hundred Fifty-five Dollars (\$9,357,255.00) from the amount of Thirty Million Dollars (\$30,000,000.00) originally 8 9 appropriated to the State Department of Health from the General 10 Revenue Fund of the State Treasury for the fiscal year ending June 11 30, 2017, by Section 169, Chapter 2, 1st Extraordinary Session, 12 O.S.L. 2017, is hereby appropriated to the Special Cash Fund of the 13 State Treasury for availability of appropriation. 14 SECTION 3. An amount of Thirteen Million Nine Hundred Twenty-15 one Thousand Six Hundred Forty-four Dollars (\$13,921,644.00) from 16 the amount of Fifty-two Million Seven Hundred Thirty-five Thousand 17 Eight Hundred Sixty-six Dollars (\$52,735,866.00) originally 18 appropriated to the State Department of Health from the General 19 Revenue Fund of the State Treasury for the fiscal year ending June 20 30, 2018, by Section 73, Chapter 3, 2nd Extraordinary Session, 21 O.S.L. 2018, is hereby appropriated to the Special Cash Fund of the 22 State Treasury for availability of appropriation. 23 SECTION 4. There is hereby appropriated to the Special Cash

Fund of the State Treasury from any monies not otherwise
