7 AS INTRODUCED

9 An Act relating to public finance; amending Section
10 4, Chapter 451, O..L. 2019 (62 O.S. Supp. 2019,
11 Section 8014), which relates to the Legislative
12 Office of Fiscal Transparency; requiring state
13 governmental entities to transmit certain information
14 to the Legislative Office of Fiscal Transparency;
15 providing for procedures to be established by the
16 Legislative Office of Fiscal Transparency; providing
17 an effective date; and declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. AMENDATORY Section 4, Chapter 451, O.S.L.
20 2019 (62 O.S. Supp. 2019, Section 8014), is amended to read as
21 follows:

22 Section 8014. A. Each agency or institution of the state
23 shall, upon request, furnish and make available to the Legislative
24 Office of Fiscal Transparency all records, documents, materials,
 personnel, information or other resources as the Office deems
 necessary to conduct performance evaluations as required by this

1 act. Any record, document, material or other information made
2 confidential by law shall be provided to the Office, which shall
3 also maintain such confidentiality. All records, documents,
4 materials or other information of the Office shall be deemed to be a
5 record of the Legislature.

6 B. Each state agency and other affected persons shall cooperate
7 with the oversight committee and the Office in the providing of any
8 information requested. The oversight committee shall have the power
9 to conduct hearings, administer oaths, issue subpoenas and compel
10 the attendance of witnesses and the production of information as
11 provided in Sections 773 and 775 of Title 74 of the Oklahoma
12 Statutes.

13 C. For the purpose of creating a data clearinghouse to aid in
14 the work of the Legislative Office of Fiscal Transparency, each
15 agency or institution of the state shall regularly transmit to the
16 Legislative Office of Fiscal Transparency raw datasets as requested
17 by the Legislative Office of Fiscal Transparency. The Legislative
18 Office of Fiscal Transparency shall adopt policies and procedures
19 pursuant to which a state agency shall be required to comply with
20 the provisions of this section, including the format in which the
21 data is transmitted, how the data is organized and such other
22 matters as the Office may prescribe.

23 SECTION 2. This act shall become effective July 1, 2020.

1 SECTION 3. It being immediately necessary for the preservation
2 of the public peace, health or safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
