8 AS INTRODUCED

9 A Resolution commending the actions of Lieutenant
10 Heath Meyer and expressing condolences and
11 appreciation to the members of Lieutenant Heath
12 Meyer's family.

13 WHEREAS, law enforcement is a dangerous occupation and the men
14 and women who perform those valuable public services do so for the
15 benefit of the citizens of the State of Oklahoma and for the people
16 who live and work in the communities of the state; and

17 WHEREAS, on July 24, 2017, Lieutenant Heath Meyer lost his life
18 resulting from the performance of his duties as a law enforcement
19 officer and in fulfillment of the high obligations imposed on law
20 enforcement officers who are sworn to protect the public from harm;
21 and

22 WHEREAS, it is fitting and appropriate to honor and acknowledge
23 the service and sacrifice of law enforcement officers and their

1 surviving family members and especially the service and sacrifice of
2 Lieutenant Heath Meyer and his family; and

3 WHEREAS, the Oklahoma House of Representatives wishes to express
4 its condolences to the family of Lieutenant Heath Meyer for their
5 loss; and

6 WHEREAS, the Oklahoma House of Representatives wishes to
7 publicly express the appreciation of the members of the chamber on
8 behalf of the people of the State of Oklahoma for the service
9 performed by Lieutenant Heath Meyer and to honor his surviving
10 family members both for the support they provided to Lieutenant
11 Heath Meyer during his lifetime and for the preservation of his
12 memory and in recognition of his valuable service on behalf of the
13 people of the State of Oklahoma; and

14 WHEREAS, in addition to this Resolution the Oklahoma Legislature
15 is in the process of passing legislation that would designate a
16 portion of Interstate 35 in the area one mile north and one mile
17 south of N. 27th Street within the municipal limits of the City of
18 Moore as the "Lt. Heath Meyer #64 Memorial Highway"; and

19 WHEREAS, the members of the Oklahoma House of Representatives
20 wish to express their sentiments that it is not possible to
21 adequately convey to Lieutenant Meyer's family the appreciation for
22 his service as a law enforcement officer or to adequately express
23 the depth of feeling resulting from his heroic actions on July 14,
24 2017; and

1 WHEREAS, the Oklahoma House of Representatives wishes to express
2 its collective support and extend to the family of Lieutenant Heath
3 Meyer the good will and privileges of the Oklahoma House of
4 Representatives.

5 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
6 OF THE 1ST SESSION OF THE 57TH OKLAHOMA LEGISLATURE:

7 THAT the most sincere appreciation be expressed to the family of
8 Lieutenant Heath Meyer.

9 THAT it is the will of the Oklahoma House of Representatives to
10 take action for enactment of legislation designating a portion of
11 Interstate 35 in the area one mile north and one mile south of N.
12 27th Street within the municipal limits of Moore as the "Lt. Heath
13 Meyer #64 Memorial Highway".

14 THAT all of the rights and privileges of the Oklahoma House of
15 Representatives be extended to the members of Lieutenant Heath
16 Meyer's family.

17 THAT copies of this resolution be provided to the family of
18 Lieutenant Heath Meyer.
