 renewable. The length of the unclassified employment shall not
 exceed the period of time for which that specific federal funding is
 provided;

5. All officers and employees of The Oklahoma State System of
Higher Education, State Board of Education and Oklahoma Department
of Career and Technology Education;

9 6. Persons employed in a professional or scientific capacity to 10 make or conduct a temporary and special inquiry, investigation, or examination on behalf of the Legislature or a committee thereof or 11 12 by authority of the Governor. These appointments and authorizations shall terminate on the first day of the regular legislative session 13 immediately following the appointment, if not terminated earlier. 14 However, nothing in this paragraph shall prevent the reauthorization 15 and reappointment of any such person. Any such appointment shall be 16 funded from the budget of the appointing authority; 17

- 16 2. Certified public accountants;
- Licensed attorneys;
- 18 4. Licensed veterinarians; and

19 5. Licensed pharmacists.

C. Effective July 1, 1996, authorization for unclassified offices, positions, or personnel contained in a bill or joint resolution shall terminate June 30 of the ensuing fiscal year after the authorization unless the authorization is codified in the

Oklahoma Statutes or the termination is otherwise provided in the
 legislation.

The appointing authority of agencies participating in the 3 D. statewide information systems project may establish unclassified 4 5 positions and appoint unclassified employees to the project as needed. Additional unclassified positions may be established, if 6 7 required, to appoint an unclassified employee to perform the duties of a permanent classified employee who is temporarily absent from a 8 9 classified position as a result of assignment to this project. All 10 unclassified appointments under this authority shall expire no later 11 than December 31, 2007, and all unclassified positions established 12 to support the project shall be abolished. Both the positions and appointments resulting from this authority shall be exempt from any 13 agency FTE limitations and any limits imposed on the number of 14 unclassified positions authorized. Permanent classified employees 15 may request a leave of absence from classified status and accept an 16 unclassified appointment and compensation with the same agency under 17 the provisions of this subsection; provided, the leave shall expire 18 no later than December 31, 2007. Employees accepting the 19 appointment and compensation shall be entitled to participate 20 without interruption in any benefit programs available to classified 21 employees, including retirement and insurance programs. Immediately 22 upon termination of an unclassified appointment pursuant to this 23 subsection, an employee on assignment from the classified service 24
