7 An Act relating to education; creating the Oklahoma  
8 Education Task Force; providing termination date;  
9 stating purpose of task force; providing for  
10 membership; setting deadline for appointments;  
11 providing for filling of vacancies; specifying  
12 deadline for organizational meeting; directing  
13 election of a chair and vice-chair; providing for  
14 selection of impartial consensus builder to work with  
15 task force; establishing quorum requirements;  
16 providing for meetings; prohibiting compensation or  
17 travel reimbursement for task force members;  
18 providing for staff assistance; requiring task force  
19 to issue report of findings by a specified date;  
20 providing for noncodification; and providing an  
21 effective date.

3 B. The task force shall be comprised of fifteen (15) members as  
4 follows:

5 1. The Superintendent of Public Instruction or designee;

6 2. The Secretary of Education and Workforce Development or  
7 designee;

8 3. A superintendent representing a school district with less  
9 than one thousand (1,000) students, appointed by the Speaker of the  
10 Oklahoma House of Representatives;

11 4. A superintendent representing a school district with less  
12 than five thousand (5,000) students, appointed by the President Pro  
13 Tempore of the Oklahoma State Senate;

14 5. A superintendent representing a school district with more  
15 than five thousand (5,000) students, appointed by the Governor;

16 6. A school principal representing a school district with less  
17 than one thousand (1,000) students, appointed by the Governor;

18 7. A school principal representing a school district with less  
19 than five thousand (5,000) students, appointed by the Speaker of the  
20 Oklahoma House of Representatives;

21 8. A school principal representing a school district with more  
22 than five thousand (5,000) students, appointed by the President Pro  
23 Tempore of the Oklahoma State Senate;

1           9. A parent of a public school student attending a school  
2 district with less than one thousand (1,000) students, appointed by  
3 the President Pro Tempore of the Oklahoma State Senate;

4           10. A parent of a public school student attending a school  
5 district with less than five thousand (5,000) students, appointed by  
6 the Governor;

7           11. A parent of a public school student attending a school  
8 district with more than five thousand (5,000) students, appointed by  
9 the Speaker of the Oklahoma House of Representatives;

10           12. Two members of the Oklahoma House of Representatives, one  
11 representing an urban area and one representing a rural area,  
12 appointed by the Speaker of the Oklahoma House of Representatives;  
13 and

14           13. Two members of the Oklahoma State Senate, one representing  
15 an urban area and one representing a rural area, appointed by the  
16 President Pro Tempore of the Oklahoma State Senate.

17           C. Appointments to the task force shall be made no later than  
18 December 31, 2019. Members of the task force shall serve at the  
19 pleasure of the appointing authority. A vacancy on the task force  
20 shall be filled by the appointing authority.

21           D. The task force shall conduct an organizational meeting no  
22 later than February 15, 2020. The task force shall elect a chair  
23 and vice-chair at the organizational meeting and determine how to  
24 select an impartial consensus builder to work with the task force.

1 A majority of the members present at a meeting shall constitute a  
2 quorum to conduct business.

3 E. The task force may meet as often as necessary to perform the  
4 duties imposed upon the task force in this act. Members of the task  
5 force shall not receive compensation or be reimbursed for travel  
6 expenses.

7 F. Staff assistance for the task force shall be provided by the  
8 Oklahoma House of Representatives and the Oklahoma State Senate.

9 G. The task force shall issue a report of its findings to the  
10 Legislature, Governor and Superintendent of Public Instruction no  
11 later than December 31, 2020.

12 SECTION 2. This act shall become effective November 1, 2019.
