6 AS INTRODUCED

7 An Act relating to motor vehicles; amending Section
8 2, Chapter 237, O.S.L. 2018 (47 O.S. Supp. 2019,
9 Section 11-801e), which relates to speeding
10 violations; deleting certain expiration date; and
11 providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY Section 2, Chapter 237, O.S.L.
14 2018 (47 O.S. Supp. 2019, Section 11-801e), is amended to read as
15 follows:

16 Section 11-801e. ~~A.~~ Notwithstanding any other provision of
17 law, any person convicted of a speeding violation of one (1) to ten
18 (10) miles per hour over the limit, pursuant to subsection B or F of
19 Section 11-801 of ~~Title 47 of the Oklahoma Statutes~~ this title,
20 shall be punished by a fine of Five Dollars (\$5.00) and costs and
21 fees not to exceed Ninety-five Dollars (\$95.00). The court clerk
22 shall collect the fine, costs and fees to be directed as follows:

23 1. The sum of Thirty-three Dollars and seventy-two cents
24 (\$33.72) for each offense of which the defendant is convicted,

1 irrespective of whether the sentence is deferred, shall cover
2 docketing of the case, filing of all papers, issuance of process,
3 warrants, order and other services to the date of judgment;

4 2. The sum of Eight Dollars and eighty cents (\$8.80) shall be
5 assessed and credited to the District Attorneys Council Revolving
6 Fund created pursuant to Section 215.28 of Title 19 of the Oklahoma
7 Statutes to defray the cost of prosecution;

8 3. The sum of Eleven Dollars (\$11.00) shall be assessed and
9 credited to the Oklahoma Court Information System Revolving Fund
10 created pursuant to Section 1315 of Title 20 of the Oklahoma
11 Statutes;

12 4. The sum of Four Dollars and fifty cents (\$4.50) shall be
13 assessed and credited to the Sheriff's Service Fee Account in the
14 county in which the conviction occurred for the purpose of enhancing
15 existing or providing additional courthouse security;

16 5. The sum of One Dollar and thirty cents (\$1.30) shall be
17 assessed and credited to the Office of the Attorney General Victim
18 Services Unit;

19 6. The sum of One Dollar and thirty cents (\$1.30) shall be
20 assessed and credited to the Child Abuse Multidisciplinary Account;

21 7. The sum of Two Dollars and twenty-five cents (\$2.25) shall
22 be assessed and credited to the Sheriff's Service Fee Account of the
23 sheriff of the county in which the arrest was made;

1 8. The sum of Four Dollars and fifty cents (\$4.50) shall be
2 assessed and credited to the Council on Law Enforcement Education
3 and Training (CLEET) Fund created pursuant to Section 1313.2 of
4 Title 20 of the Oklahoma Statutes;

5 9. The sum of Four Dollars and fifty cents (\$4.50) shall be
6 assessed. Four Dollars and ten cents (\$4.10) of each fee received
7 pursuant to this paragraph shall be credited to the A.F.I.S. Fund
8 created by Section 150.25 of Title 74 of the Oklahoma Statutes and
9 the balance deposited into the General Revenue Fund by the court
10 clerk. The payments shall be made to the appropriate fund by the
11 court clerk on a monthly basis as set forth by subsection I of
12 Section 1313.2 of Title 20 of the Oklahoma Statutes;

13 10. The sum of Four Dollars and fifty cents (\$4.50) shall be
14 assessed. Four Dollars and twenty-eight cents (\$4.28) of each fee
15 received pursuant to this paragraph shall be collected and sent to
16 the Oklahoma State Bureau of Investigation for deposit into the
17 Forensic Science Improvement Revolving Fund created by Section
18 150.35 of Title 74 of the Oklahoma Statutes. The balance shall be
19 retained by the municipal court clerk;

20 11. The sum of Nine Dollars (\$9.00) shall be assessed and
21 forwarded monthly in one check or draft to the Department of Public
22 Safety to be deposited in the Department of Public Safety Patrol
23 Vehicle Revolving Fund;

1 12. Pursuant to subsection C of Section 220 of Title 19 of the
2 Oklahoma Statutes, the court clerk shall assess an administrative
3 fee of ten percent (10%) on fees assessed in paragraphs 2, 4, 5, 6,
4 8, 9, 10 and 11 of this ~~subsection~~ section which shall be deposited
5 in the Court Clerk's Revolving Fund created pursuant to Section 220
6 of Title 19 of the Oklahoma Statutes; and

7 13. Pursuant to subsection D of Section 220 of Title 19 of the
8 Oklahoma Statutes, the court clerk shall assess an administrative
9 fee of fifteen percent (15%) on fees assessed in paragraphs 2, 4, 5,
10 6, 8, 9, 10 and 11 of this ~~subsection and~~ section which shall be
11 deposited in the District Court Revolving Fund created pursuant to
12 Section 220 of Title 19 of the Oklahoma Statutes.

13 ~~B. Provisions of this section shall remain in effect until~~
14 ~~November 1, 2020.~~

15 SECTION 2. This act shall become effective October 31, 2020.
