16	SECTION 1. From the funds appropriated to the Oklahoma

18	2765 of the 1st Session of the 57th Oklahoma Legislature, the sum of						
19	One Million Dollars (\$1,000,000.00) shall be transferred to the

23	SECTION 2. This act shall become effective July 1, 2019.
