17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 5020A of Title 63, unless there
20	is created a duplication in numbering, reads as follows:
21	There is hereby created in the State Treasury a fund for the
22	Oklahoma Health Care Authority to be designated the "Rate
23	Preservation Fund". The fund shall be a continuing fund, not
24	subject to fiscal year limitations, and shall consist of monies

designated to the fund by law. All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by the Authority for the sole purpose of maintaining reimbursement rates to providers when decreases in the state's Federal Medical Assistance Percentage (FMAP) rate would otherwise result in implementation of reimbursement rate decreases by the Authority. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment. The Administrator of the Authority may request the Director of the Office of Management and Enterprise Services to transfer monies between the Rate Preservation Fund and any other fund of the Authority as needed for the expenditure of funds.

SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
