11	An Act relating to the Office of Management and Enterprise Services; requiring that portions of
12	certain appropriated funds be used for certain purposes; prohibiting supplantation of funding;
13	requiring a certain amount of funding be budgeted for a stated purpose; providing an effective date; and
14	declaring an emergency.

17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. From the funds appropriated to the Office of
19	Management and Enterprise Services in Enrolled House Bill No. 2765
20	of the 1st Session of the 57th Oklahoma Legislature, the sum of Six
21	Million Three Hundred Thousand Dollars (\$6,300,000.00) shall be used
22	to fund operations of the Capital Assets Management and Central
23	Accounting and Reporting Divisions. These funds shall not supplant
24	the current Capital Assets Management and Central Accounting and

Reporting Divisions funding and the agency shall budget no less than
 the total of the amount budgeted in the fiscal year ending June 30,
 2019, plus the amount listed above for this purpose.

SECTION 2. From the funds appropriated to the Office of 4 5 Management and Enterprise Services in Enrolled House Bill No. 2765 of the 1st Session of the 57th Oklahoma Legislature, the sum of One 6 Million Five Hundred Thousand Dollars (\$1,500,000.00) shall be used 7 to provide for the Pay For Success program. These funds shall not 8 9 supplant the current Pay for Success program funding and the agency 10 shall budget no less than the total of the amount budgeted in the 11 fiscal year ending June 30, 2019, plus the amount listed above for 12 this purpose.

SECTION 3. From the funds appropriated to the Office of 13 Management and Enterprise Services in Enrolled House Bill No. 2765 14 of the 1st Session of the 57th Oklahoma Legislature, the sum of 15 Sixteen Million Four Hundred Seventeen Thousand Dollars 16 (\$16,417,000.00) shall be used to fund the Information Services 17 These funds shall not supplant the current Information 18 Division. Services Division funding and the agency shall budget no less than 19 the total of the amount budgeted in the fiscal year ending June 30, 20 2019, plus the amount listed above for this purpose. 21

SECTION 4. This act shall become effective July 1, 2019.
 SECTION 5. It being immediately necessary for the preservation
 of the public peace, health or safety, an emergency is hereby
