10 COMMITTEE SUBSTITUTE

11 An Act relating to the Oklahoma Historical Society;
12 requiring that portions of certain appropriated funds
13 be used for certain purposes; providing an effective
14 date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. From the funds appropriated to the Oklahoma
17 Historical Society in Enrolled House Bill No. 2765 of the 1st
18 Session of the 57th Oklahoma Legislature, not less than Seventy
19 Thousand Dollars (\$70,000.00) shall be used to provide for the Will
20 Rogers Memorial Museum. These funds shall be used to provide
21 additional funding for the Will Rogers Memorial Museum and shall be
22 used to supplement rather than replace existing resources.

23 SECTION 2. From the funds appropriated to the Oklahoma
24 Historical Society in Enrolled House Bill No. 2765 of the 1st

1 Session of the 57th Oklahoma Legislature, the sum of One Million
2 Five Hundred Thousand Dollars (\$1,500,000.00) shall be transferred
3 to the 1921 Tulsa Race Riot Centennial Memorial Revolving Fund
4 created in Section 8207 of Title 74 of the Oklahoma Statutes.

5 SECTION 3. From the funds appropriated to the Oklahoma
6 Historical Society in Enrolled House Bill No. 2765 of the 1st
7 Session of the 57th Oklahoma Legislature, not less than Six Hundred
8 Thousand Dollars (\$600,000.00) shall be used to provide for roof and
9 structure rehabilitation of the Oklahoma History Center.

10 SECTION 4. From the funds appropriated to the Oklahoma
11 Historical Society in Enrolled House Bill No. 2765 of the 1st
12 Session of the 57th Oklahoma Legislature, not less than Two Hundred
13 Fifty Thousand Dollars (\$250,000.00) shall be used to provide for
14 the Stafford Air and Space Museum. These funds shall be used to
15 provide additional funding for the Stafford Air and Space Museum and
16 shall be used to supplement rather than replace existing resources.

17 SECTION 5. This act shall become effective July 1, 2019.

18 SECTION 6. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
