structure rehabilitation of the Oklahoma History Center.

SECTION 4. From the funds appropriated to the Oklahoma

Historical Society in Enrolled House Bill No. 2765 of the 1st

Session of the 57th Oklahoma Legislature, not less than Two Hundred

Fifty Thousand Dollars (\$250,000.00) shall be used to provide for

the Stafford Air and Space Museum. These funds shall be used to

provide additional funding for the Stafford Air and Space Museum and

shall be used to supplement rather than replace existing resources.

SECTION 5. This act shall become effective July 1, 2019.

SECTION 6. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
