Committee Substitute (CS)

The CS for HB 2516 authorizes the holder or owner of a title on a vehicle to, at the time of initial application for registration or application for renewal, inform the Tax Commission that the owner, lessee or someone who may be operating the vehicle is suffering from a communication disorder. Information provided to the Tax Commission must be made available to law enforcement through the Tax Commission's vehicle registration system. A communication disorder is defined by the measure as impairment in the ability to receive, send, process and comprehend concepts or verbal, nonverbal and graphic symbol systems.

The measure proposes amendment to Section 1112 of Title 47 by providing that any owner or lessee of a noncommercial vehicle possessing a certificate of title may, at the time of initial application for registration or application for renewal, inform the Tax Commission that the owner, lessee or someone who may be operating the vehicle is deaf, hard-of-hearing or autistic or suffers from Apraxia or a communication disorder. Once provided, that information is to be made available to law enforcement through the Tax Commission's vehicle registration system to assist law enforcement in identifying the operator of the vehicle as possibly being deaf, hard-of-hearing or autistic or suffers from Apraxia or a communication disorder. It further define "communication disorder" as impairment in the ability to receive, send, process and comprehend concepts or verbal, nonverbal and graphic symbol systems.
