Supp. 2018, Sections 509.2 and 509.6); providing for 16 codification; and providing an effective date. 17 18 19 20 21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 22 SECTION 1. AMENDATORY 70 O.S. 2011, Section 509.8, is 23 amended to read as follows: 24

Section 509.8 The procedure provided for herein for resolving impasses shall be the exclusive recourse of the organization. shall be illegal for the <del>organization</del> board of education or school district employees, including all those defined in Section 1-116 of this title, to strike or threaten to strike or otherwise close schools or interfere with school operations as a means of resolving differences with the board of education, the State Department of Education, the State Board of Education, the Legislature or any other public official or public body. Any member of an organization person engaging in a strike, shutdown or related activities shall be denied the full amount of his or her wages during the period of such violation. If the organization or its members engage in a strike, then the organization shall cease to be recognized as representative of the unit and the school district shall be relieved of the duty to negotiate with such organization or its representatives, and if the person holds a certificate issued by the State Board of Education, such certificate shall be permanently revoked.

SECTION 2. AMENDATORY 70 O.S. 2011, Section 509.9, is amended to read as follows:

Section 509.9 No employee shall be discriminated against by the board of education, superintendent or any other administrative officer of a district or by any employee organization, its officers or any member thereof because of his <u>or her</u> exercise or nonexercise of rights under this act. It shall be prohibited for an employee
