7 AS INTRODUCED

8 A Resolution commending the actions of Lieutenant
9 Heath Meyer and expressing condolences and
10 appreciation to the members of Lieutenant Heath
11 Meyer's family.

12 WHEREAS, law enforcement is a dangerous occupation and the men
13 and women who perform those valuable public services do so for the
14 benefit of the citizens of the State of Oklahoma and for the people
15 who live and work in the communities of the state; and

16 WHEREAS, on July 24, 2017, Lieutenant Heath Meyer lost his life
17 resulting from the performance of his duties as a law enforcement
18 officer and in fulfillment of the high obligations imposed on law
19 enforcement officers who are sworn to protect the public from harm;
20 and

21 WHEREAS, it is fitting and appropriate to honor and acknowledge
22 the service and sacrifice of law enforcement officers and their
23 surviving family members and especially the service and sacrifice of
24 Lieutenant Heath Meyer and his family; and

1 WHEREAS, the Oklahoma House of Representatives wishes to express
2 its condolences to the family of Lieutenant Heath Meyer for their
3 loss; and

4 WHEREAS, the Oklahoma House of Representatives wishes to
5 publicly express the appreciation of the members of the chamber on
6 behalf of the people of the State of Oklahoma for the service
7 performed by Lieutenant Heath Meyer and to honor his surviving
8 family members both for the support they provided to Lieutenant
9 Heath Meyer during his lifetime and for the preservation of his
10 memory and in recognition of his valuable service on behalf of the
11 people of the State of Oklahoma; and

12 WHEREAS, in addition to this Resolution the Oklahoma Legislature
13 is in the process of passing legislation that would designate a
14 portion of Interstate 35 in the area one mile north and one mile
15 south of N. 27th Street within the municipal limits of the City of
16 Moore as the "Lt. Heath Meyer #64 Memorial Highway"; and

17 WHEREAS, the members of the Oklahoma House of Representatives
18 wish to express their sentiments that it is not possible to
19 adequately convey to Lieutenant Meyer's family the appreciation for
20 his service as a law enforcement officer or to adequately express
21 the depth of feeling resulting from his heroic actions on July 14,
22 2017; and

23 WHEREAS, the Oklahoma House of Representatives wishes to express
24 its collective support and extend to the family of Lieutenant Heath

1 Meyer the good will and privileges of the Oklahoma House of
2 Representatives.

3 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
4 OF THE 1ST SESSION OF THE 57TH OKLAHOMA LEGISLATURE:

5 THAT the most sincere appreciation be expressed to the family of
6 Lieutenant Heath Meyer.

7 THAT it is the will of the Oklahoma House of Representatives to
8 take action for enactment of legislation designating a portion of
9 Interstate 35 in the area one mile north and one mile south of N.
10 27th Street within the municipal limits of Moore as the "Lt. Heath
11 Meyer #64 Memorial Highway".

12 THAT all of the rights and privileges of the Oklahoma House of
13 Representatives be extended to the members of Lieutenant Heath
14 Meyer's family.

15 THAT copies of this resolution be provided to the family of
16 Lieutenant Heath Meyer.
