BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified  
in the Oklahoma Statutes as Section 2400 of Title 74, unless there  
is created a duplication in numbering, reads as follows:

This act shall be known and may be cited as the "Oklahoma Golf  
Trail Creation Act".

1       SECTION 2.       NEW LAW       A new section of law to be codified  
2 in the Oklahoma Statutes as Section 2401 of Title 74, unless there  
3 is created a duplication in numbering, reads as follows:

4       There is hereby created the Oklahoma Golf Trail Commission,  
5 hereinafter referred to as the "Commission", and the Oklahoma Golf  
6 Trail, hereinafter referred to as the "Golf Trail".

7       SECTION 3.       NEW LAW       A new section of law to be codified  
8 in the Oklahoma Statutes as Section 2402 of Title 74, unless there  
9 is created a duplication in numbering, reads as follows:

10       A.   The Commission shall consist of nine (9) members, each of  
11 whom shall serve a term of six (6) years.

12       B.   Five members shall be appointed by the Lieutenant Governor,  
13 two members shall be appointed by the Speaker of the House of  
14 Representatives, and two members shall be appointed by the President  
15 Pro Tempore of the Senate.

16       Members selected to the Commission must be knowledgeable about  
17 the Oklahoma golf industry including:

- 18       1.   Golf course marketing;  
19       2.   Golf course ownership;  
20       3.   Golf course management; or  
21       4.   Tourism and commerce in Oklahoma.

22       C.   Commission members may be removed for cause. Whenever a  
23 vacancy on the Commission occurs by death, resignation, or  
24 otherwise, the appointing authority shall fill the same by

1 appointment, and the appointee shall hold office during the  
2 unexpired term. Each member shall hold office until a successor has  
3 been appointed.

4 D. Five members of the Commission shall constitute a quorum,  
5 and the vote of the majority of members present shall be necessary  
6 for any action to be taken by the Commission.

7 E. No vacancy in the membership of the Commission shall impair  
8 the rights of a quorum to exercise and perform all the rights and  
9 duties of the Commission.

10 F. The Commission shall appoint from the Commission the chair,  
11 vice-chair, and secretary.

12 G. The Commission is authorized and directed to adopt rules  
13 pursuant to the provisions of the Administrative Procedures Act to  
14 execute the powers and duties of the Commission.

15 H. The Commission may meet monthly and shall meet at least  
16 quarterly. The Commission may meet at such other times as it deems  
17 necessary for effectively performing its duties and  
18 responsibilities. Special meetings may be called by the chair or by  
19 any three members of the Commission. The meetings of the Commission  
20 shall be subject to the Oklahoma Open Meeting Act.

21 I. The Commission is hereby declared to be a governmental  
22 agency and instrumentality of the State of Oklahoma with authority  
23 to exercise the rights, privileges, and functions hereinafter  
24 specified in addition to those it now has.

1 J. The Commission shall evaluate and approve a list of not less  
2 than fifteen but not more than twenty-five golf courses annually to  
3 be listed as the official Oklahoma Golf Trail for tourism and  
4 marketing purposes. The list shall be reviewed every year for  
5 renewal of approval.

6 K. Members of the Commission shall not be personally liable for  
7 damages from actions in furtherance of the Commission.

8 SECTION 4. NEW LAW A new section of law to be codified  
9 in the Oklahoma Statutes as Section 2403 of Title 74, unless there  
10 is created a duplication in numbering, reads as follows:

11 A. There are hereby granted to and imposed on the Commission,  
12 and in any commission or body which may hereafter succeed to the  
13 powers, rights, and duties of the Commission, the additional powers,  
14 rights, and duties hereinafter more specifically provided.

15 B. The mission of the Commission is to increase rounds of golf  
16 played at the Oklahoma Golf Trail Member Courses to stimulate  
17 economic development, enhance tourism, attract new residents and  
18 retirees to the state, and to elevate the quality of life and  
19 experience in Oklahoma.

20 C. The Commission is hereby authorized to:

- 21 1. Sue and be sued;
- 22 2. Adopt, use, and alter an official seal;
- 23 3. Make bylaws for the management and regulation of its  
24 affairs;

1       4. Appoint, prescribe the duties, and fix the compensation for  
2 officers, agents, and employees;

3       5. Make contracts and execute instruments as in the judgment of  
4 the Commission are necessary or convenient to the exercise of the  
5 powers conferred upon it by law;

6       6. Sell advertising; provided, that such advertising shall be  
7 approved by the Commission prior to acceptance for publication; and

8       7. Promulgate rules and policies necessary and convenient to  
9 the exercise of the powers conferred upon it by law.

10      D. The Commission shall be responsible for the following:

11      1. Evaluating and selecting marketing options for the Oklahoma  
12 Golf Trail;

13      2. Set membership fees for Golf Trail courses;

14      3. Evaluate courses based on condition, location, course fees,  
15 and any other variable relevant for Golf Trail course selection; and

16      4. Develop interagency, intra-agency, and public-private  
17 collaborations to help advance the awareness and mission of the  
18 Oklahoma Golf Trail.

19      SECTION 5.       NEW LAW       A new section of law to be codified  
20 in the Oklahoma Statutes as Section 2404 of Title 74, unless there  
21 is created a duplication in numbering, reads as follows:

22      The Commission shall be able to accept private donations to fund  
23 operations until permanent appropriations can be allocated.

SECTION 6. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval."

6       SECTION 8.       NEW LAW       A new section of law to be codified  
7 in the Oklahoma Statutes as Section 2401 of Title 74, unless there  
8 is created a duplication in numbering, reads as follows:

9       There is hereby created the Oklahoma Golf Trail Commission,  
10 hereinafter referred to as the "Commission", and the Oklahoma Golf  
11 Trail, hereinafter referred to as the "Golf Trail".

12       SECTION 9.       NEW LAW       A new section of law to be codified  
13 in the Oklahoma Statutes as Section 2402 of Title 74, unless there  
14 is created a duplication in numbering, reads as follows:

15       A.   The Commission shall consist of nine (9) members, each of  
16 whom shall serve a term of six (6) years.

17       B.   Five members shall be appointed by the Lieutenant Governor,  
18 two members shall be appointed by the Speaker of the Oklahoma House  
19 of Representatives, and two members shall be appointed by the  
20 President Pro Tempore of the Oklahoma State Senate.

21       Members selected to the Commission must be knowledgeable about

3        C. Commission members may be removed for cause. Whenever a

6 appointment, and the appointee shall hold office during the  
7 unexpired term. Each member shall hold office until a successor has  
8 been appointed.

12       E. No vacancy in the membership of the Commission shall impair  
13 the rights of a quorum to exercise and perform all the rights and

17       G. The Commission is authorized and directed to adopt rules  
18 pursuant to the provisions of the Administrative Procedures Act to  
19 execute the powers and duties of the Commission.

20       H. The Commission may meet monthly and shall meet at least

22 necessary for effectively performing its duties and

9        SECTION 12. It being immediately necessary for the preservation

11 declared to exist, by reason whereof this act shall take effect and  
12 be in full force from and after its passage and approval.
