"G. 1. A three-day nonresident medical marijuana patient permit shall be available to any nonresident medical marijuana patient licensee.

- 2. Upon presentation of a valid medical marijuana license and state-issued driver license or state-issued identification card by a nonresident medical marijuana patient to a licensed medical marijuana dispensary, the medical marijuana dispensary shall verify the authenticity and status of the nonresident medical marijuana patient license through the website or telephone verification system of the Oklahoma Medical Marijuana Authority. Upon said verification, the medical marijuana dispensary may issue a three-day nonresident medical marijuana patient permit to the person. The cost of the three-day nonresident medical marijuana patient permit shall be Seventy-five Dollars (\$75.00). Renewal of the three-day nonresident medical marijuana patient permit shall be granted with resubmission of the permit fee and verification of the authenticity and status of the nonresident medical marijuana patient license. There shall be no limit to the number of times a person may receive a three-day nonresident medical marijuana patient permit.
- 3. A person who has been issued a three-day nonresident medical marijuana patient permit shall be authorized to obtain no more than a three-day supply of medical marijuana. As used in this subsection, a "three-day supply" means the amount of medical marijuana reasonably necessary to ensure uninterrupted availability
