of Medicolegal Investigations, the Oklahoma State
Bureau of Narcotics and Dangerous Drugs Control, the
Department of Public Safety, the Office of the
Attorney General, the Court of Criminal Appeals,
district attorneys and the District Attorneys
Council, the Supreme Court, the Oklahoma Indigent
Defense System, the Pardon and Parole Board, the
Multiple Injury Trust Fund, the Special Cash Fund,
the Education Reform Revolving Fund, the County
Improvements for Roads and Bridges Fund, the
Maintenance of State Buildings Revolving Fund, the
State-Tribal Litigation Revolving Fund, the Oklahoma
Quick Action Closing Fund, and The State Emergency
Fund; stating amounts of the appropriations; stating
purposes and restrictions; authorizing certain
expenditures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 EDUCATION

2 SECTION 1. There is hereby appropriated to the State Board of
3 Education from any monies not otherwise appropriated from the
4 General Revenue Fund of the State Treasury for the fiscal year
5 ending June 30, 2022, the sum of One Billion Four Hundred Seventy-
6 one Million Three Hundred Eighty-four Thousand Two Hundred Seventy-
7 one Dollars (\$1,471,384,271.00) or so much thereof as may be
8 necessary for the financial support of public schools.

9 SECTION 2. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Education Reform Revolving Fund created in Section 34.89 of Title 62
12 of the Oklahoma Statutes, the sum of Eight Hundred Seventy-five
13 Million Two Hundred Eighty-nine Thousand Six Hundred Thirty-one
14 Dollars (\$875,289,631.00) or so much thereof as may be necessary for
15 the financial support of public schools.

16 SECTION 3. The State Board of Education is hereby authorized to
17 expend during the fiscal year ending June 30, 2022, from the Common
18 Education Technology Revolving Fund of the State Treasury, the sum
19 of Forty-seven Million Three Hundred Seventy-two Thousand Two
20 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
21 may be necessary for the financial support of public schools.

22 SECTION 4. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Mineral Leasing Fund of the State Treasury for the fiscal year

1 ending June 30, 2022, the sum of Five Million Two Hundred Twenty-
2 five Thousand Dollars (\$5,225,000.00) or so much thereof as may be
3 necessary for the financial support of public schools.

4 SECTION 5. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 Mineral Leasing Fund of the State Treasury for the fiscal year
7 ending June 30, 2020, the sum of Three Million Five Hundred Twenty-
8 four Thousand Four Hundred Six Dollars (\$3,524,406.00) or so much
9 thereof as may be necessary for the financial support of public
10 schools.

11 SECTION 6. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the
14 fiscal year ending June 30, 2022, the sum of Twenty-six Million
15 Seventy-seven Thousand Five Hundred Dollars (\$26,077,500.00) or so
16 much thereof as may be necessary for the financial support of public
17 schools.

18 SECTION 7. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the
21 fiscal year ending June 30, 2020, the sum of Eight Million Three
22 Hundred Seventy-three Thousand Five Hundred Ninety-two Dollars
23 (\$8,373,592.00) or so much thereof as may be necessary for the
24 financial support of public schools.

1 SECTION 8. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2022, the sum of One Hundred Eight Million Nine
5 Hundred Nineteen Thousand Twenty-six Dollars (\$108,919,026.00) or so
6 much thereof as may be necessary for the support of public schools
7 activities.

8 SECTION 9. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2021, the sum of Sixty Million Dollars
12 (\$60,000,000.00) or so much thereof as may be necessary for the
13 purchase of textbooks and instructional materials.

14 SECTION 10. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2022, the sum of Three Hundred Forty-seven Million
18 Eighty-one Thousand Six Hundred Forty-four Dollars (\$347,081,644.00)
19 or so much thereof as may be necessary for the Certified Employee
20 Health Benefit Allowance.

21 SECTION 11. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 General Revenue Fund of the State Treasury for the fiscal year
24 ending June 30, 2022, the sum of One Hundred Eighty-eight Million

1 Four Hundred Fifty-five Thousand Three Hundred Seventy-seven Dollars
2 (\$188,455,377.00) or so much thereof as may be necessary for the
3 Support Personnel Health Benefit Allowance.

4 SECTION 12. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2022, the sum of Fifteen Million Twenty-seven
8 Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much
9 thereof as may be necessary for administrative and support functions
10 of the State Department of Education.

11 SECTION 13. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the
14 fiscal year ending June 30, 2022, the sum of Two Million Eight
15 Hundred Ninety-seven Thousand Five Hundred Dollars (\$2,897,500.00)
16 or so much thereof as may be necessary for transfer to the School
17 Consolidation Assistance Fund.

18 SECTION 14. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the
21 fiscal year ending June 30, 2020, the sum of Nine Hundred Thirty
22 Thousand Three Hundred Ninety-nine Dollars (\$930,399.00) or so much
23 thereof as may be necessary for transfer to the School Consolidation
24 Assistance Fund.

1 SECTION 15. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2022, the sum of Two Million Eight
5 Hundred Ninety-seven Thousand Five Hundred Dollars (\$2,897,500.00)
6 or so much thereof as may be necessary for transfer to the Teachers'
7 Retirement System Dedicated Revenue Revolving Fund.

8 SECTION 16. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2020, the sum of Nine Hundred Thirty
12 Thousand Three Hundred Ninety-nine Dollars (\$930,399.00) or so much
13 thereof as may be necessary for transfer to the Teachers' Retirement
14 System Dedicated Revenue Revolving Fund.

15 SECTION 17. There is hereby appropriated to the Oklahoma Arts
16 Council from any monies not otherwise appropriated from the General
17 Revenue Fund of the State Treasury for the fiscal year ending June
18 30, 2022, the sum of Three Million Four Thousand Two Hundred Five
19 Dollars (\$3,004,205.00) or so much thereof as may be necessary to
20 perform the duties imposed upon the Oklahoma Arts Council by law.

21 SECTION 18. There is hereby appropriated to the State Board of
22 Career and Technology Education from any monies not otherwise
23 appropriated from the General Revenue Fund of the State Treasury for
24 the fiscal year ending June 30, 2022, the sum of One Hundred Thirty-

1 four Million Six Hundred Forty-one Thousand Seven Hundred Twenty-
2 three Dollars (\$134,641,723.00) or so much thereof as may be
3 necessary to perform the duties imposed upon the State Board of
4 Career and Technology Education by law.

5 SECTION 19. There is hereby appropriated to the State Board of
6 Career and Technology Education from any monies not otherwise
7 appropriated from the Oklahoma Education Lottery Trust Fund of the
8 State Treasury for the fiscal year ending June 30, 2022, the sum of
9 Three Million One Hundred Eighty-seven Thousand Two Hundred Fifty
10 Dollars (\$3,187,250.00) pursuant to paragraph 2 of subsection F of
11 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
12 the State Board of Career and Technology Education for the education
13 and general operating budgets of the institutions and for other
14 programs, construction, renovations or repairs administered by the
15 State Board of Career and Technology Education.

16 SECTION 20. There is hereby appropriated to the State Board of
17 Career and Technology Education from any monies not otherwise
18 appropriated from the Oklahoma Education Lottery Trust Fund of the
19 State Treasury for the fiscal year ending June 30, 2020, the sum of
20 One Million Twenty-three Thousand Four Hundred Thirty-nine Dollars
21 (\$1,023,439.00) pursuant to paragraph 2 of subsection F of Section
22 713 of Title 3A of the Oklahoma Statutes for allocation by the State
23 Board of Career and Technology Education for the education and
24 general operating budgets of the institutions and for other

1 programs, construction, renovations or repairs administered by the
2 State Board of Career and Technology Education.

3 SECTION 21. There is hereby appropriated to the Office of
4 Educational Quality and Accountability from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2022, the sum of One Million Sixty-
7 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much
8 thereof as may be necessary to perform the duties imposed upon the
9 Office of Educational Quality and Accountability by law. Of those
10 funds appropriated, the sum of Sixty Thousand Dollars (\$60,000.00)
11 shall be deposited in the Teacher Certification Scholarship
12 Revolving Fund created pursuant to Section 6-187C of Title 70 of the
13 Oklahoma Statutes. Of those funds appropriated, the sum of One
14 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in
15 the Education Leadership Oklahoma Revolving Fund created pursuant to
16 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

17 SECTION 22. There is hereby appropriated to the Office of
18 Educational Quality and Accountability from any monies not otherwise
19 appropriated from the Special Cash Fund of the State Treasury the
20 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
21 thereof as may be necessary to perform the duties imposed upon the
22 Office of Educational Quality and Accountability by law.

23 SECTION 23. There is hereby appropriated to the Oklahoma
24 Educational Television Authority from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2022, the sum of Three Million Two
3 Hundred Four Thousand Four Dollars (\$3,204,004.00) or so much
4 thereof as may be necessary to perform the duties imposed upon the
5 Oklahoma Educational Television Authority by law.

6 SECTION 24. There is hereby appropriated to the Oklahoma State
7 Regents for Higher Education from any monies not otherwise
8 appropriated from the General Revenue Fund of the State Treasury for
9 the fiscal year ending June 30, 2022, the sum of Five Hundred
10 Eighty-five Million Two Hundred Thirty-seven Thousand Twenty-four
11 Dollars (\$585,237,024.00) or so much thereof as may be necessary for
12 allocation by the Oklahoma State Regents for Higher Education
13 pursuant to the provisions of Article XIII-A of the Oklahoma
14 Constitution for the education and general operating budgets of the
15 institutions and for other programs, construction, renovations or
16 repairs administered by the Oklahoma State Regents for Higher
17 Education. Of those funds appropriated, the sum of Three Million
18 One Hundred Forty-nine Thousand Eight Hundred Ninety-seven Dollars
19 (\$3,149,897.00) shall be transferred to the Oklahoma Tuition
20 Equalization Grant Trust Fund to implement the provisions of the
21 Oklahoma Tuition Equalization Grant Act.

22 SECTION 25. The Oklahoma State Regents for Higher Education are
23 hereby authorized to expend during the fiscal year ending June 30,
24 2022, the sum of Forty-seven Million Three Hundred Seventy-two

1 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
2 Higher Education Capital Revolving Fund of the State Treasury for
3 allocation by the Oklahoma State Regents for Higher Education
4 pursuant to the provisions of Article XIII-A of the Oklahoma
5 Constitution for the education and general operating budgets of the
6 institutions and for other programs, construction, renovations or
7 repairs administered by the Oklahoma State Regents for Higher
8 Education.

9 SECTION 26. The Oklahoma State Regents for Higher Education are
10 hereby authorized to expend during the fiscal year ending June 30,
11 2022, the sum of Forty-seven Million Three Hundred Seventy-two
12 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
13 Oklahoma Student Aid Revolving Fund of the State Treasury for
14 allocation by the Oklahoma State Regents for Higher Education
15 pursuant to the provisions of Article XIII-A of the Oklahoma
16 Constitution for the education and general operating budgets of the
17 institutions and for other programs, construction, renovations or
18 repairs administered by the Oklahoma State Regents for Higher
19 Education.

20 SECTION 27. There is hereby appropriated to the Oklahoma State
21 Regents for Higher Education from the Master Teacher Program Fund
22 (Fund 713), the sum of Eighty-six Million Six Hundred Thousand
23 Dollars (\$86,600,000.00) or so much thereof as may be necessary for
24 allocation by the Oklahoma State Regents for Higher Education

1 pursuant to the provisions of Article XIII-A of the Oklahoma
2 Constitution for the education and general operating budgets of the
3 institutions and for other programs, construction, renovations or
4 repairs administered by the Oklahoma State Regents for Higher
5 Education.

6 SECTION 28. There is hereby appropriated to the Oklahoma State
7 Regents for Higher Education from any monies not otherwise
8 appropriated from the General Revenue Fund of the State Treasury for
9 the fiscal year ending June 30, 2022, the sum of Eleven Million
10 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars
11 (\$11,764,823.00) or so much thereof as may be necessary for
12 expenditures for concurrent enrollment pursuant to Section 628.13 of
13 Title 70 of the Oklahoma Statutes.

14 SECTION 29. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the Oklahoma Education Lottery Trust Fund of the
17 State Treasury for the fiscal year ending June 30, 2022, the sum of
18 Twenty-two Million Eight Hundred Ninety Thousand Two Hundred Fifty
19 Dollars (\$22,890,250.00) pursuant to paragraph 2 of subsection F of
20 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
21 the Oklahoma State Regents for Higher Education pursuant to the
22 provisions of Article XIII-A of the Oklahoma Constitution for
23 construction, renovations or repairs administered by the Oklahoma
24 State Regents for Higher Education or for any other purpose

1 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
2 of the Oklahoma Statutes.

3 SECTION 30. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2020, the sum of
7 Seven Million Three Hundred Fifty Thousand One Hundred Fifty-three
8 Dollars (\$7,350,153.00) pursuant to paragraph 2 of subsection F of
9 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
10 the Oklahoma State Regents for Higher Education pursuant to the
11 provisions of Article XIII-A of the Oklahoma Constitution for
12 construction, renovations or repairs administered by the Oklahoma
13 State Regents for Higher Education or for any other purpose
14 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
15 of the Oklahoma Statutes.

16 SECTION 31. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2022, the sum of Four Million Two
20 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars
21 (\$4,232,974.00) or so much thereof as may be necessary for the
22 general operating budget of the Administrative Offices of the
23 Oklahoma State Regents for Higher Education.

1 SECTION 32. There is hereby appropriated to the Commissioners
2 of the Land Office from any monies not otherwise appropriated from
3 the Commissioners of the Land Office Fund of the State Treasury for
4 the fiscal year ending June 30, 2022, the sum of Eight Million Three
5 Hundred Seventy-nine Thousand Two Hundred Seventy-six Dollars
6 (\$8,379,276.00) or so much thereof as may be necessary to perform
7 the duties imposed upon the Commissioners of the Land Office by law.

8 SECTION 33. There is hereby appropriated to the Oklahoma
9 Department of Libraries from any monies not otherwise appropriated
10 from the General Revenue Fund of the State Treasury for the fiscal
11 year ending June 30, 2022, the sum of Four Million Three Hundred
12 Forty-six Thousand Three Hundred Fifteen Dollars (\$4,346,315.00) or
13 so much thereof as may be necessary to perform the duties imposed
14 upon the Oklahoma Department of Libraries by law.

15 SECTION 34. There is hereby appropriated to the Physician
16 Manpower Training Commission from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2022, the sum of Six Million Five
19 Hundred Forty-six Thousand Eight Hundred Seventy-seven Dollars
20 (\$6,546,877.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Physician Manpower Training Commission
22 by law.

23 SECTION 35. There is hereby appropriated to the Physician
24 Manpower Training Commission from any monies not otherwise

1 appropriated from the Special Cash Fund of the State Treasury the
2 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
3 thereof as may be necessary to perform the duties imposed upon the
4 Physician Manpower Training Commission by law.

5 SECTION 36. There is hereby appropriated to the Board of
6 Trustees of the Oklahoma School of Science and Mathematics from any
7 monies not otherwise appropriated from the General Revenue Fund of
8 the State Treasury for the fiscal year ending June 30, 2022, the sum
9 of Six Million Eight Hundred Eleven Thousand Three Hundred Seventy-
10 three Dollars (\$6,811,373.00) or so much thereof as may be necessary
11 to perform the duties imposed upon the Board of Trustees of the
12 Oklahoma School of Science and Mathematics by law.

13 SECTION 37. There is hereby appropriated to the Oklahoma Center
14 for the Advancement of Science and Technology from any monies not
15 otherwise appropriated from the General Revenue Fund of the State
16 Treasury for the fiscal year ending June 30, 2022, the sum of
17 Fifteen Million Two Hundred Ninety-six Thousand Five Hundred Forty-
18 two Dollars (\$15,296,542.00) or so much thereof as may be necessary
19 to perform the duties imposed upon the Oklahoma Center for the
20 Advancement of Science and Technology by law. Of those funds
21 appropriated, the sum of Seven Million Six Hundred Eighteen Thousand
22 Six Hundred Seventeen Dollars (\$7,618,617.00) shall be deposited in
23 the Research Support Revolving Fund, created pursuant to Section
24 5060.11 of Title 74 of the Oklahoma Statutes, provided One Million

1 Five Hundred Thousand Dollars (\$1,500,000.00) of these funds shall
2 be dedicated to Applied Research and Development for Industry
3 Innovation. Of those funds appropriated, the sum of Two Million
4 Seven Hundred Fifty-nine Thousand Three Hundred Eight Dollars
5 (\$2,759,308.00) shall be deposited in the Seed-capital Revolving
6 Fund, created pursuant to Section 5060.21 of Title 74 of the
7 Oklahoma Statutes.

8 FINANCE

9 SECTION 38. There is hereby appropriated to the Oklahoma
10 Department of Commerce from any monies not otherwise appropriated
11 from the General Revenue Fund of the State Treasury for the fiscal
12 year ending June 30, 2022, the sum of Twenty-two Million Seventy-
13 seven Thousand Six Hundred Eighty Dollars (\$22,077,680.00) or so
14 much thereof as may be necessary to perform the duties imposed upon
15 the Oklahoma Department of Commerce by law.

16 SECTION 39. There is hereby appropriated to the Rural Economic
17 Action Plan Fund from any monies not otherwise appropriated from the
18 General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2022, the sum of Fifteen Million Four Hundred
