18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:							
19	SECTION 1. NEW LAW A new section of law not to be							
20	codified in the Oklahoma Statutes reads as follows:							
21	From the funds appropriated to the Oklahoma Historical Society							
22	in Enrolled Senate Bill No. 1040 of the 2nd Session of the 58th							
23	Oklahoma Legislature, the sum of Sixty-five Thousand Dollars							
24	(\$65,000.00) shall, under the direction of the Executive Director of

the Oklahoma Historical Society, be allocated to a theatrical production associated with the Smithsonian.

SECTION 2. Appropriations made by this act, not including appropriations made for capital outlay purposes, may be budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23) or may be budgeted for the fiscal year ending June 30, 2024 (hereafter FY-24). Funds budgeted for FY-23 may be encumbered only through June 30, 2023, and must be expended by November 15, 2023. Any funds remaining after November 15, 2023, and not budgeted for FY-24, shall lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-24 may be encumbered only through June 30, 2024. Any funds remaining after November 15, 2024, shall lapse to the credit of the proper fund for the then current fiscal year. These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-23, and not required to pay obligations for that fiscal year, may be budgeted for FY-24, after the agency to which the funds have been appropriated has prepared and submitted a budget work program revision removing these funds from the FY-23 budget work program and after such revision has been approved by the Office of Management and Enterprise Services.
