1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. NEW LAW A new section of law to be codified 3 in the Oklahoma Statutes as Section 2400 of Title 74, unless there 4 is created a duplication in numbering, reads as follows:

5 This act shall be known and may be cited as the "Oklahoma Golf 6 Trail Creation Act".

7 SECTION 2. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 2401 of Title 74, unless there
9 is created a duplication in numbering, reads as follows:

10 There is hereby created the Oklahoma Golf Trail Commission, 11 hereinafter referred to as the "Commission", and the Oklahoma Golf 12 Trail, hereinafter referred to as the "Golf Trail".

13 SECTION 3. NEW LAW A new section of law to be codified 14 in the Oklahoma Statutes as Section 2402 of Title 74, unless there 15 is created a duplication in numbering, reads as follows:

A. The Commission shall consist of nine (9) members, each of whom shall serve a term of six (6) years following the expiration of the initial term.

B. The Governor shall appoint members to the Commission with
the advice and consent of the Senate for terms of years as follows:
1. Three members whose initial terms of office shall expire

22 January 1, 2024; and

23 2. Two members whose initial terms of office shall expire24 January 1, 2026.

C. The Lieutenant Governor shall appoint members to the
 Commission with the advice and consent of the Senate for terms of
 years as follows:

Two members whose initial terms of office shall expire
 January 1, 2023; and

6 2. Two members whose initial terms of office shall expire7 January 1, 2025.

8 D. Members selected to the Commission must be knowledgeable9 about the Oklahoma golf industry including:

10 1. Golf course marketing;

- 11 2. Golf course ownership;
- 12 3. Golf course management; or

13 4. Tourism and commerce in Oklahoma.

E. Commission members may be removed for cause. Whenever a vacancy on the Commission occurs by death, resignation, or otherwise, the appointing authority shall fill the same by appointment, and the appointee shall hold office during the unexpired term. Each member shall hold office until a successor has been appointed.

F. Five members of the Commission shall constitute a quorum, and the vote of the majority of members present shall be necessary for any action to be taken by the Commission.

G. No vacancy in the membership of the Commission shall impair
 the rights of a quorum to exercise and perform all the rights and
 duties of the Commission.

H. The Commission shall elect from among its membership a
chair, vice-chair, and secretary. The chair or vice-chair shall
preside at all meetings. The chair, vice-chair, and secretary shall
perform such duties as may be decided by the Commission in order to
effectively administer this act.

9 I. The Commission is authorized and directed to adopt rules 10 pursuant to the provisions of the Administrative Procedures Act to 11 execute the powers and duties of the Commission.

J. The Commission may meet monthly and shall meet at least quarterly. The Commission may meet at such other times as it deems necessary for effectively performing its duties and responsibilities. Special meetings may be called by the chair or by any three members of the Commission. The meetings of the Commission shall be subject to the Oklahoma Open Meeting Act.

18 K. The Commission is hereby declared to be a governmental 19 agency and instrumentality of the State of Oklahoma with authority 20 to exercise the rights, privileges, and functions hereinafter 21 specified in addition to those it now has.

L. The Commission shall evaluate and approve a list of not less than fifteen but not more than twenty-five golf courses annually to be listed as the official Oklahoma Golf Trail for tourism and

1 marketing purposes. The list shall be reviewed every year for 2 renewal of approval.

3 M. Members of the Commission shall not be personally liable for4 damages from actions in furtherance of the Commission.

N. Members of the Commission shall serve without compensation
but shall be reimbursed for all actual and necessary expenses
incurred in the performance of their duties in accordance with the
State Travel Reimbursement Act.

9 SECTION 4. NEW LAW A new section of law to be codified 10 in the Oklahoma Statutes as Section 2403 of Title 74, unless there 11 is created a duplication in numbering, reads as follows:

A. There are hereby granted to and imposed on the Commission, and in any commission or body which may hereafter succeed to the powers, rights, and duties of the Commission, the additional powers, rights, and duties hereinafter more specifically provided.

B. The mission of the Commission is to increase rounds of golf played at the Oklahoma Golf Trail Member Courses to stimulate economic development, enhance tourism, attract new residents and retirees to the state, and to elevate the quality of life and experience in Oklahoma.

21 C. The Commission is hereby authorized to:

22 1. Sue and be sued;

23 2. Adopt, use, and alter an official seal;

3. Make bylaws for the management and regulation of its
 affairs;

3 4. Appoint, prescribe the duties, and fix the compensation for4 officers, agents, and employees;

5. Make contracts and execute instruments as in the judgment of
6 the Commission are necessary or convenient to the exercise of the
7 powers conferred upon it by law;

8 6. Sell advertising; provided, that such advertising shall be9 approved by the Commission prior to acceptance for publication; and

Promulgate rules and policies necessary and convenient to
 the exercise of the powers conferred upon it by law.

12 D. The Commission shall be responsible for the following:

Evaluating and selecting marketing options for the Oklahoma
 Golf Trail;

15 2. Setting membership fees for Golf Trail courses;

16 3. Evaluating courses based on condition, location, course 17 fees, and any other variable relevant for Golf Trail course 18 selection; and

Developing interagency, intra-agency, and public-private
 collaborations to help advance the awareness and mission of the
 Oklahoma Golf Trail.

22 SECTION 5. NEW LAW A new section of law to be codified 23 in the Oklahoma Statutes as Section 2404 of Title 74, unless there 24 is created a duplication in numbering, reads as follows:
