entity, regardless of whether the private entity or the school receives anything of value in return.

- B. A public school, public charter school, or public virtual charter school shall not enter into a transaction with an individual or entity that performs abortions, induces abortions, or provides abortions unless the entity is a hospital licensed pursuant to Section 1-702 of Title 63 which has enacted a policy to only provide abortions when deemed medically necessary to protect the life of the mother.
- C. The State Board of Education shall promulgate rules to implement the provisions of this section.
- D. Each school district board of education and governing board of a public charter school or public virtual charter school shall adopt a policy for the implementation of the provisions of this section.
- E. The State Board of Education shall require the board of education of a public school and the governing board of a public charter school or public virtual charter school that knowingly violates the provisions of this section to appear before the Board to determine:
  - 1. Why the school violated the provisions of this section; and
- 22 2. How to prevent the violation of provisions of this section in the future.

SECTION 2. This act shall become effective July 1, 2022.
