## 1 STATE OF OKLAHOMA 2 2nd Session of the 58th Legislature (2022) COMMITTEE SUBSTITUTE 3 SENATE BILL 615 By: Bullard and Bergstrom 4 5 6 7 COMMITTEE SUBSTITUTE An Act relating to schools; amending 70 O.S. 2021, 8 Section 11-105.1, which relates to sex education 9 curriculum and materials; requiring curriculum and materials used in connection to a meeting with a school counselor or used as part of any other class, 10 program, or activity to be available for inspection; prohibiting a student from being required to 11 participate in certain meeting with a school counselor or certain activities which discuss sexual 12 orientation and gender identity; requiring a superintendent or designee to approve all curriculum 13 and materials to be used for certain matters pertaining to sexual orientation, gender identity, or 14 a meeting with a counselor; requiring certain prior written notification to include a list of curriculum 15 and materials to be used in certain activities; providing contents of notification; providing certain 16 construction; defining terms; providing an effective date; and declaring an emergency. 17 18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 19 20 SECTION 1. 70 O.S. 2021, Section 11-105.1, is AMENDATORY amended to read as follows: 21 Section 11-105.1. A. All curriculum and materials including 22 supplementary materials which will be used to teach or will be used 23 for or in connection with a sex education class or program which is 24

1 designed for the exclusive purpose of discussing sexual behavior or 2 attitudes, or any test, meeting with a school counselor, survey, or questionnaire whose primary purpose is to elicit responses on sexual 3 behavior or attitudes; or any curriculum, materials, test, survey, 4 5 questionnaire, activity, or instruction of any kind related to sexual orientation and gender identity, regardless of whether it is 6 offered as part of a sex education class or program or as part of 7 any other class, program, or activity shall be available through the 8 9 superintendent or a designee of the school district for inspection by parents and guardians of the student who will be involved with 10 11 the <u>instruction</u>, class, program <del>or</del>, test, <u>activity</u>, survey, or 12 questionnaire. Such curriculum, materials, classes, programs, tests, meetings with school counselors, surveys, or questionnaires 13 shall include information about consent and shall have as one of its 14 primary purposes the teaching of or informing students about the 15 practice of abstinence. For the purposes of this section, "consent" 16 shall have the same meaning as that provided by Section 113 of Title 17 21 of the Oklahoma Statutes. The superintendent or a designee of 18 the school district shall provide prior written notification to the 19 parents or guardians of the students involved of their right to 20 inspect the curriculum and material and of their obligation to 21 notify the school in writing if they do not want their child to 22 participate in the <u>instruction</u>, class, program, test, <u>activity</u>, 23 survey, or questionnaire. Each local board of education shall 24

determine the means of providing written notification to the parents and guardian which will ensure effective notice in an efficient and appropriate manner. No student shall be required to participate in a sex education class or program or participate in a meeting with a school counselor which discusses sexual behavior or attitudes, or any instruction, class, program, test, activity, survey, or questionnaire which discusses sexual orientation and gender identity if a parent or guardian of the student objects in writing to such participation. If the type of instruction, program, test, activity, survey, or questionnaire referred to in this section is a part of or is taught during a credit course, a student may be required to enroll in the course but shall not be required to receive instruction in or participate in the program, test, activity, survey, or questionnaire if a parent or guardian objects in writing.

B. The superintendent or a designee of a school district in which sex education or matters pertaining to sexual orientation or gender identity is taught or a program is offered which is designed for the exclusive purpose of discussing sexual behavior or attitudes or matters pertaining to sexual orientation or gender identity shall approve all curriculum and materials which will be used for such education and any test, meeting with a school counselor, survey, or questionnaire whose primary purpose is to elicit responses on sexual behavior or attitudes used in the school prior to their use in the classroom or school. The teacher or school counselor involved in

- the <u>instruction</u>, class, program, <u>testing</u> <u>test</u>, <u>activity</u>, <u>meeting</u>, or survey shall submit the curriculum, materials, tests, or surveys to the superintendent or a designee for approval prior to their use in the classroom or school. This section shall not apply to those students enrolled in classes, programs, <u>testings</u> <u>tests</u>, or surveys offered through an alternative education program.
  - C. The prior written notification required by subsection A of this section shall include a list with the audio-visual or written curriculum and materials to be used in the instruction, class, program, test, activity, meeting, or survey. The notification shall include:
  - 1. A link to the audio-visual or written curriculum and materials to be used if they are available electronically; or

- 2. Information on how and where to review a hard copy of the audio-visual or written curriculum and materials.
- D. The provisions of this section shall not be construed to require written notification prior to:
- 1. A teacher responding to student questions during class

  regarding sexual orientation and gender identity as it relates to

  any topic of instruction;
  - 2. Referring to the sexual orientation or gender identity of any historic person, group, or public figure when such information provides necessary context in relation to any topic of instruction; or

1 3. Referring to sexual orientation and gender identity if necessary to address a disciplinary matter, such as an instance of 2 bullying. 3 E. The provisions of this section shall not be construed to 4 5 require that a public school offer instruction, a class, a program, a test, an activity, a meeting, or a survey on sex education, sexual 6 behavior or attitudes, sexual orientation, or gender identity. 7 F. For the purposes of this section: 8 9 1. "Gender identity" means one's psychological sense of their gender. Gender identity may also be known as "gender dysphoria," a 10 clinically significant distress or impairment related to a strong 11 desire to be of another gender, which may include a desire to change 12 primary and/or secondary sex characteristics; and 13 2. "Sexual orientation" means an individual's actual or 14 perceived orientation as heterosexual, homosexual, or bisexual. 15 SECTION 2. This act shall become effective July 1, 2022. 16 SECTION 3. It being immediately necessary for the preservation 17 of the public peace, health or safety, an emergency is hereby 18 declared to exist, by reason whereof this act shall take effect and 19 be in full force from and after its passage and approval. 20 21 2/22/2022 10:51:39 AM 58-2-3536 EΒ 22
