18	SECTION 1. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 11-103.12 of Title 70, unless
20	there is created a duplication in numbering, reads as follows:
21	A. No teacher, administrator or other employee of a state
22	agency, school district, charter school or virtual charter school
23	shall be required to engage in training, orientation or therapy that

- 1. One race or sex is inherently superior to another race or sex;
 - 2. An individual, by virtue of his or her race or sex, is inherently racist, sexist or oppressive, whether consciously or unconsciously;
- 3. An individual should be discriminated against or receive adverse treatment solely or partly because of his or her race or sex;
 - 4. Members of one race or sex cannot and should not attempt to treat others without respect to race or sex;
 - 5. An individual's moral character is necessarily determined by his or her race or sex;
- 6. An individual, by virtue of his or her race or sex, bears responsibility for actions committed in the past by other members of the same race or sex;
- 7. Any individual should feel discomfort, guilt, anguish or any other form of psychological distress on account of his or her race or sex; or

8. Meritocracy or traits such as a hard work ethic are racist or sexist or were created by members of a particular race to oppress members of another race. C. The State Board of Education may promulgate rules to implement the provisions of this section. SECTION 2. This act shall become effective July 1, 2021. SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval. 58-1-2054 4/6/2021 10:52:42 AM EB
