

8 An Act relating to the Health Care Workforce Training
9 Commission; making appropriations; stating purposes;
10 requiring that portions of certain funds be utilized
11 for certain grants; allowing certain funds to be
12 reserved for administration; requiring rules and
13 procedures to be established; and allowing certain
14 funds to be reserved.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Health Care
17 Workforce Development Revolving Fund, created in Enrolled House Bill
18 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
19 any monies not otherwise appropriated from the Statewide Recovery
20 Fund of the State Treasury created in Enrolled House Bill No. 3349
21 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Ten
22 Million Dollars (\$10,000,000.00) or so much thereof as may be
23 necessary to establish a grant program with Southwestern Oklahoma
24 State University for the purpose of recruiting, educating, and
stabilizing Oklahoma's health care workforce.

1 SECTION 2. There is hereby appropriated to the Health Care
2 Workforce Development Revolving Fund from any monies not otherwise
3 appropriated from the Statewide Recovery Fund, created in Enrolled
4 House Bill No. 4453 of the 2nd Session of the 58th Oklahoma
5 Legislature, of the State Treasury created in Enrolled House Bill
6 No. 3349 of the 2nd Session of the 58th Oklahoma Legislature, the
7 sum of One Million Seven Hundred Eighty Thousand Dollars
8 (\$1,780,000.00) or so much thereof as may be necessary to establish
9 a grant program with Murray State College for the purpose of
10 recruiting, educating, and stabilizing Oklahoma's health care
11 workforce.

12 SECTION 3. There is hereby appropriated to the Health Care
13 Workforce Development Revolving Fund, created in Enrolled House Bill
14 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
15 any monies not otherwise appropriated from the Statewide Recovery
16 Fund of the State Treasury created in Enrolled House Bill No. 3349
17 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Six
18 Hundred Thirty-four Thousand Eight Hundred Fifty Dollars
19 (\$634,850.00) or so much thereof as may be necessary to establish a
20 grant program with Moore Norman Technology Center for the purpose of
21 recruiting, educating, and stabilizing Oklahoma's health care
22 workforce.

23 SECTION 4. There is hereby appropriated to the Health Care
24 Workforce Development Revolving Fund, created in Enrolled House Bill

1 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
2 any monies not otherwise appropriated from the Statewide Recovery
3 Fund of the State Treasury created in Enrolled House Bill No. 3349
4 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Nine
5 Million Seven Hundred Sixty-nine Thousand Six Hundred Eighty-nine
6 Dollars (\$9,769,689.00) or so much thereof as may be necessary to
7 establish a grant program with Oklahoma City Community College for
8 the purpose of recruiting, educating, and stabilizing Oklahoma's
9 health care workforce.

10 SECTION 5. There is hereby appropriated to the Health Care
11 Workforce Development Revolving Fund, created in Enrolled House Bill
12 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
13 any monies not otherwise appropriated from the Statewide Recovery
14 Fund of the State Treasury created in Enrolled House Bill No. 3349
15 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
16 Eight Million Eight Hundred Forty-nine Thousand Two Hundred Twenty-
17 three Dollars (\$8,849,223.00) or so much thereof as may be necessary
18 to establish a grant program with Tulsa Community College for the
19 purpose of recruiting, educating, and stabilizing Oklahoma's health
20 care workforce.

21 SECTION 6. There is hereby appropriated to the Health Care
22 Workforce Development Revolving Fund, created in Enrolled House Bill
23 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
24 any monies not otherwise appropriated from the Statewide Recovery

1 Fund of the State Treasury created in Enrolled House Bill No. 3349
2 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Nine
3 Million Four Hundred Sixty-four Thousand Seven Hundred Ten Dollars
4 (\$9,464,710.00) or so much thereof as may be necessary to establish
5 a grant program with Rose State College for the purpose of
6 recruiting, educating, and stabilizing Oklahoma's health care
7 workforce.

8 SECTION 7. There is hereby appropriated to the Health Care
9 Workforce Development Revolving Fund, created in Enrolled House Bill
10 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
11 any monies not otherwise appropriated from the Statewide Recovery
12 Fund of the State Treasury created in Enrolled House Bill No. 3349
13 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Four
14 Million Five Hundred Thirty-seven Thousand Five Hundred Dollars
15 (\$4,537,500.00) or so much thereof as may be necessary to establish
16 a grant program with Care Providers Oklahoma for the purpose of
17 recruiting, educating, and stabilizing Oklahoma's health care
18 workforce.

19 SECTION 8. There is hereby appropriated to the Health Care
20 Workforce Development Revolving Fund, created in Enrolled House Bill
21 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
22 any monies not otherwise appropriated from the Statewide Recovery
23 Fund of the State Treasury created in Enrolled House Bill No. 3349
24 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Six

1 Million Five Hundred Eighty-five Thousand Four Hundred Eighty-seven
2 Dollars (\$6,585,487.00) or so much thereof as may be necessary to
3 establish grant programs with Southeastern Oklahoma State University
4 for the purpose of recruiting, educating, and stabilizing Oklahoma's
5 health care workforce.

6 SECTION 9. There is hereby appropriated to the Health Care
7 Workforce Development Revolving Fund, created in Enrolled House Bill
8 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
9 any monies not otherwise appropriated from the Statewide Recovery
10 Fund of the State Treasury created in Enrolled House Bill No. 3349
11 of the 2nd Session of the 58th Oklahoma Legislature, the sum of One
12 Hundred Ten Thousand Dollars (\$110,000.00) or so much thereof as may
13 be necessary to establish a grant program with Cameron University
14 for the purpose of recruiting, educating, and stabilizing Oklahoma's
15 health care workforce.

16 SECTION 10. There is hereby appropriated to the Health Care
17 Workforce Development Revolving Fund, created in Enrolled House Bill
18 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
19 any monies not otherwise appropriated from the Statewide Recovery
20 Fund of the State Treasury created in Enrolled House Bill No. 3349
21 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
22 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
23 may be necessary to establish a grant program with Carl Albert State
24

1 College for the purpose of recruiting, educating, and stabilizing
2 Oklahoma's health care workforce.

3 SECTION 11. There is hereby appropriated to the Health Care
4 Workforce Development Revolving Fund, created in Enrolled House Bill
5 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
6 any monies not otherwise appropriated from the Statewide Recovery
7 Fund of the State Treasury created in Enrolled House Bill No. 3349
8 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
9 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
10 may be necessary to establish a grant program with Connors State
11 College for the purpose of recruiting, educating, and stabilizing

13 SECTION 12. There is hereby appropriated to the Health Care
14 Workforce Development Revolving Fund, created in Enrolled House Bill

16 any monies not otherwise appropriated from the Statewide Recovery
17 Fund of the State Treasury created in Enrolled House Bill No. 3349
18 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
19 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as

23 SECTION 13. There is hereby appropriated to the Health Care

2 any monies not otherwise appropriated from the Statewide Recovery
3 Fund of the State Treasury created in Enrolled House Bill No. 3349

5 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as

9 SECTION 14. There is hereby appropriated to the Health Care

12 any monies not otherwise appropriated from the Statewide Recovery
13 Fund of the State Treasury created in Enrolled House Bill No. 3349
14 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
15 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
16 may be necessary to establish a grant program with Northeastern
17 Oklahoma Agricultural and Mechanical College for the purpose of
18 recruiting, educating, and stabilizing Oklahoma's health care
19 workforce.

20 SECTION 15. There is hereby appropriated to the Health Care
21 Workforce Development Revolving Fund from any monies not otherwise
22 appropriated from the Statewide Recovery Fund, created in Enrolled
23 House Bill No. 4453 of the 2nd Session of the 58th Oklahoma
24 Legislature, of the State Treasury created in Enrolled House Bill

1 No. 3349 of the 2nd Session of the 58th Oklahoma Legislature, the
2 sum of One Hundred Fifty Thousand Dollars (\$150,000.00) or so much
3 thereof as may be necessary to establish a grant program with
4 Northeastern State University for the purpose of recruiting,
5 educating, and stabilizing Oklahoma's health care workforce.

6 SECTION 16. There is hereby appropriated to the Health Care
7 Workforce Development Revolving Fund, created in Enrolled House Bill
8 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
9 any monies not otherwise appropriated from the Statewide Recovery
10 Fund of the State Treasury created in Enrolled House Bill No. 3349
11 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
12 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
13 may be necessary to establish a grant program with Northern Oklahoma
14 College for the purpose of recruiting, educating, and stabilizing
15 Oklahoma's health care workforce.

16 SECTION 17. There is hereby appropriated to the Health Care
17 Workforce Development Revolving Fund, created in Enrolled House Bill
18 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
19 any monies not otherwise appropriated from the Statewide Recovery
20 Fund of the State Treasury created in Enrolled House Bill No. 3349
21 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
22 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
23 may be necessary to establish a grant program with Northwestern
24

1 Oklahoma State University for the purpose of recruiting, educating,
2 and stabilizing Oklahoma's health care workforce.

3 SECTION 18. There is hereby appropriated to the Health Care
4 Workforce Development Revolving Fund, created in Enrolled House Bill
5 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
6 any monies not otherwise appropriated from the Statewide Recovery
7 Fund of the State Treasury created in Enrolled House Bill No. 3349
8 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
9 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
10 may be necessary to establish a grant program with Redlands
11 Community College for the purpose of recruiting, educating, and
12 stabilizing Oklahoma's health care workforce.

13 SECTION 19. There is hereby appropriated to the Health Care
14 Workforce Development Revolving Fund, created in Enrolled House Bill
15 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
16 any monies not otherwise appropriated from the Statewide Recovery
17 Fund of the State Treasury created in Enrolled House Bill No. 3349
18 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
19 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
20 may be necessary to establish a grant program with Rogers State
21 University for the purpose of recruiting, educating, and stabilizing
22 Oklahoma's health care workforce.

23 SECTION 20. There is hereby appropriated to the Health Care
24 Workforce Development Revolving Fund, created in Enrolled House Bill

1 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
2 any monies not otherwise appropriated from the Statewide Recovery
3 Fund of the State Treasury created in Enrolled House Bill No. 3349
4 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
5 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
6 may be necessary to establish a grant program with Seminole State
7 College for the purpose of recruiting, educating, and stabilizing
8 Oklahoma's health care workforce.

9 SECTION 21. There is hereby appropriated to the Health Care
10 Workforce Development Revolving Fund, created in Enrolled House Bill
11 No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from
12 any monies not otherwise appropriated from the Statewide Recovery
13 Fund of the State Treasury created in Enrolled House Bill No. 3349
14 of the 2nd Session of the 58th Oklahoma Legislature, the sum of
15 Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as
16 may be necessary to establish a grant program with Western Oklahoma
17 State College for the purpose of recruiting, educating, and
18 stabilizing Oklahoma's health care workforce.

19 SECTION 22. The Commission may reserve not more than two
20 percent (2%) from each grant program authorized in this act for
21 purposes of administering the program.

22 SECTION 23. The Health Care Workforce Training Commission shall
23 promulgate rules and establish procedures for evaluating and
24

1 awarding grant applications for grant programs provided for in this
2 act.
