6 An Act relating to abortion; amending Section 18,  
7 Chapter 308, O.S.L. 2021, which relates to contingent  
8 effective date; modifying applicability of certain  
9 provisions; modifying conditions under which certain  
10 provisions will become effective; repealing Sections  
11 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16,  
12 and 17, Chapter 308, O.S.L. 2021, which relate to  
13 abortion; and declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY Section 18, Chapter 308, O.S.L.  
16 2021, is amended to read as follows:

17 Section 18. ~~This act~~ Section 1, Chapter 308, O.S.L. 2021 shall  
18 only become effective ~~on and after the certification of~~ when the  
19 Attorney General certifies that:

20 1. The United States Supreme Court ~~overrules the central~~  
21 ~~holding of~~ has overruled in whole or in part Roe v. Wade, 410 U.S.  
22 113 (1973), ~~reaffirmed by~~ and Planned Parenthood of Southeastern  
23 Pennsylvania v. Casey, 505 U.S. 833 (1992), ~~thereby restoring to~~  
24 such that the State of Oklahoma ~~the authority to prohibit abortion~~  
may enforce Section 861 of Title 21 of the Oklahoma Statutes or

1 enact a similar statute prohibiting abortion throughout pregnancy;  
2 or

3 2. An amendment to the United States Constitution is adopted  
4 ~~that restores to~~ such that the State of Oklahoma ~~the authority to~~  
5 ~~prohibit abortion~~ may enforce Section 861 of Title 21 of the  
6 Oklahoma Statutes or enact a similar statute prohibiting abortion  
7 throughout pregnancy.

8 SECTION 2. REPEALER Sections 2, 3, 4, 5, 6, 7, 8, 9, 10,  
9 11, 12, 13, 14, 15, 16, and 17, Chapter 308, O.S.L. , are hereby  
10 repealed.

11 SECTION 3. It being immediately necessary for the preservation  
12 of the public peace, health or safety, an emergency is hereby  
13 declared to exist, by reason whereof this act shall take effect and  
14 be in full force from and after its passage and approval.
