Except as provided in subsection B of this section, it shall 19 be unlawful for any person convicted of any felony in any court of 20 this state or of another state or of the United States to have in 21 his or her possession or under his or her immediate control, or in 22 any vehicle which the person is operating, or in which the person is 23

riding as a passenger, or at the residence where the convicted

- person resides, any pistol, imitation or homemade pistol, altered air or toy pistol, machine gun, sawed-off shotgun or sawed-off rifle, or any other dangerous or deadly firearm.
 - B. Any person who has previously been convicted of a nonviolent felony in any court of this state or of another state or of the United States, and who has received a full and complete pardon from the proper authority and has not been convicted of any other felony offense which has not been pardoned, shall have restored the right to possess any firearm or other weapon prohibited by subsection A of this section, the right to apply for and carry a handgun, concealed or unconcealed, pursuant to the Oklahoma Self-Defense Act or as otherwise permitted by law, and the right to perform the duties of a peace officer, gunsmith, and for firearms repair all other duties requiring gun rights.
 - C. 1. Notwithstanding the provisions of subsection B of this section, any person who:
 - a. has previously been convicted of a nonviolent felony,
 and
 - b. has completed the entirety of the sentence imposed for the offense and for a period of five (5) years since the completion of the sentence for the last felony offense has had no additional misdemeanor or felony offense convictions or charges pending,

- shall have restored the right to possess, carry, or transport any
 non-semi-automatic firearm, may apply for and carry a handgun,
 concealed or unconcealed, pursuant to the provisions of the Oklahoma
 Self-Defense Act or as otherwise permitted by law and shall have the
 right to perform the duties of a gunsmith and all other duties
 requiring gun rights.

 2. A person who has gun rights restored pursuant to this
 - 2. A person who has gun rights restored pursuant to this provision shall have those rights forfeited upon conviction of a subsequent misdemeanor or felony violation.
 - 3. A person convicted of any of the following non-violent felony offenses shall not be eligible to have gun rights restored as provided in this subsection:
 - <u>a.</u> <u>child endangerment, as provided in Section 852.1 of</u> this title,
 - b. domestic abuse, domestic abuse of a pregnant woman, domestic abuse in the presence of a child, and domestic abuse resulting in great bodily injury, as provided in Section 644 of this title,
 - c. incest, as provided in Section 885 of this title,
 - d. indecent exposure, as provided in Section 1021 of this
 title,
 - e. sexual assault, as provided in Section 681 of this
 title,
 - f. stalking, as provided in Section 1173 of this title,

- g. violations of a protective order, as provided in

 Section 1173 of this title and Section 60.6 of Title

 22 of the Oklahoma Statutes, and
- h. violations of the Sex Offender Registration Act, as provided in Sections 587, 590, and 590.1 of Title 57 of the Oklahoma Statutes.
- <u>D.</u> It shall be unlawful for any person serving a term of probation for any felony in any court of this state or of another state or of the United States or under the jurisdiction of any alternative court program to have in his or her possession or under his or her immediate control, or at his or her residence, or in any passenger vehicle which the person is operating or is riding as a passenger, any pistol, shotgun or rifler including any imitation or homemade pistol, altered air or toy pistol, toy shotgun or toy rifle, while such person is subject to supervision, probation, parole or inmate status.
- D. E. It shall be unlawful for any person previously adjudicated as a delinquent child or a youthful offender for the commission of an offense, which would have constituted a felony offense if committed by an adult, to have in the possession of the person or under the immediate control of the person, or have in any vehicle which he or she is driving or in which the person is riding as a passenger, or at the residence of the person, any pistol, imitation or homemade pistol, altered air or toy pistol, machine

gun, sawed-off shotgun or sawed-off rifle, or any other dangerous or deadly firearm within ten (10) years after such adjudication;

provided, that nothing in this subsection shall be construed to prohibit the placement of the person in a home with a full-time duly appointed peace officer who is certified by the Council on Law

Enforcement Education and Training (CLEET) pursuant to the provisions of Section 3311 of Title 70 of the Oklahoma Statutes.

E. F. It shall be unlawful for any person who is an alien illegally or unlawfully in the United States to have in the possession of the person or under the immediate control of the person, or in any vehicle the person is operating, or at the residence where the person resides, any pistol, imitation or homemade pistol, altered air or toy pistol, shotgun, rifle or any other dangerous or deadly firearm; provided, that nothing in this subsection applies to prohibit the transport or detention of the person by law enforcement officers or federal immigration authorities. Any person who violates the provisions of this subsection shall, upon conviction, be guilty of a misdemeanor punishable by a fine of Two Hundred Fifty Dollars (\$250.00).

- 2 | Self-Defense Act shall, upon conviction, be guilty of a felony

- 11 H. I. For purposes of this section, "sawed-off shotgun" or
- 12 | "sawed-off rifle" shall mean any shotgun or rifle which the barrel
- 13 or barrels has have been illegally shortened to any in length.
- 14 I. J. For purposes of this section, "altered toy pistol" shall
- 15 mean any toy weapon which has been altered from its original
- 16 | manufactured state to resemble a real weapon.
- 17 J. K. For purposes of this section, "altered air pistol" shall
- 18 | mean any air pistol manufactured to propel projectiles by air
- 19 pressure which has been altered from its original manufactured
- 20 state.
- 21 K. L. For purposes of this section, "alternative court program"
- 22 | shall mean any drug court, Anna McBride or mental health court, DUI
- 23 | court or veterans court.
- SECTION 2. This act shall become effective November 1, 2022.
