The Board on Legislative Compensation created 17 by Section 21 of Article V of the Oklahoma Constitution shall meet 18 on the third Tuesday of October in every odd-numbered year at nine 19 o'clock a.m. in the State Capitol Building, at which meeting the 20 Board shall review the compensation paid to members of the State 21 Legislature and, if necessary, change the compensation. 22 The Board may, at the call of its chairman or upon a В. 23 majority vote of its membership, hold such additional meetings as 24 are necessary to carry out its official duties.

- C. Any change in legislative compensation shall be made by the Board no later than the third Tuesday of November in said odd-numbered year.
 - <u>D.</u> Five members of the Board shall constitute a quorum and a majority vote of such quorum shall be necessary for the Board to act. The appointed members of said Board shall serve terms which run concurrently with the terms of the respective appointing authorities and shall serve at their pleasure. The Director of the Office of Management and Enterprise Services and the Chair of the Oklahoma Tax Commission shall serve as Secretary to the Board ex officio members of the Board as required by Section 21 of Article V of the Oklahoma Constitution.
 - E. The Executive Director of the Legislative Office of Fiscal

 Transparency shall serve as secretary to the Board and provide staff

 support to the Board.
 - $\underline{\text{F.}}$ The Board shall elect such other officers as they deem needed from their membership.
- G. No member of the Board shall be a lobbyist as required to be registered pursuant to the Oklahoma Campaign Compliance and Ethical Standards Act.
- 21 SECTION 2. This act shall become effective July 1, 2022.
- SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby
