Fund; stating amounts of the appropriations; stating  
purposes and restrictions; authorizing certain  
expenditures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of  
Education from any monies not otherwise appropriated from the  
General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2022, the sum of One Billion Four Hundred Seventy-  
2 one Million Three Hundred Eighty-four Thousand Two Hundred Seventy-  
3 one Dollars (\$1,471,384,271.00) or so much thereof as may be  
4 necessary for the financial support of public schools.

5 SECTION 2. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Education Reform Revolving Fund created in Section 34.89 of Title 62  
8 of the Oklahoma Statutes the sum of Eight Hundred Seventy-five  
9 Million Two Hundred Eighty-nine Thousand Six Hundred Thirty-one  
10 Dollars (\$875,289,631.00) or so much thereof as may be necessary for  
11 the financial support of public schools.

12 SECTION 3. The State Board of Education is hereby authorized to  
13 expend during the fiscal year ending June 30, 2022, from the Common  
14 Education Technology Revolving Fund of the State Treasury the sum of  
15 Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred  
16 Ninety-nine Dollars (\$47,372,299.00) or so much thereof as may be  
17 necessary for the financial support of public schools.

18 SECTION 4. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 Mineral Leasing Fund of the State Treasury for the fiscal year  
21 ending June 30, 2022, the sum of Five Million Two Hundred Twenty-  
22 five Thousand Dollars (\$5,225,000.00) or so much thereof as may be  
23 necessary for the financial support of public schools.

1 SECTION 5. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Mineral Leasing Fund of the State Treasury for the fiscal year  
4 ending June 30, 2020, the sum of Three Million Five Hundred Twenty-  
5 four Thousand Four Hundred Six Dollars (\$3,524,406.00) or so much  
6 thereof as may be necessary for the financial support of public  
7 schools.

8 SECTION 6. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2022, the sum of Twenty-six Million  
12 Seventy-seven Thousand Five Hundred Dollars (\$26,077,500.00) or so  
13 much thereof as may be necessary for the financial support of public  
14 schools.

15 SECTION 7. There is hereby appropriated to the State Board of  
16 Education from any monies not otherwise appropriated from the  
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
18 fiscal year ending June 30, 2020, the sum of Eight Million Three  
19 Hundred Seventy-three Thousand Five Hundred Ninety-two Dollars  
20 (\$8,373,592.00) or so much thereof as may be necessary for the  
21 financial support of public schools.

22 SECTION 8. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2022, the sum of One Hundred Eight Million Nine  
2 Hundred Nineteen Thousand Twenty-six Dollars (\$108,919,026.00) or so  
3 much thereof as may be necessary for the support of public schools  
4 activities.

5 SECTION 9. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 General Revenue Fund of the State Treasury for the fiscal year  
8 ending June 30, 2021, the sum of Sixty Million Dollars  
9 (\$60,000,000.00) or so much thereof as may be necessary for the  
10 purchase of textbooks and instructional materials.

11 SECTION 10. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 General Revenue Fund of the State Treasury for the fiscal year  
14 ending June 30, 2022, the sum of Three Hundred Forty-seven Million  
15 Eighty-one Thousand Six Hundred Forty-four Dollars (\$347,081,644.00)  
16 or so much thereof as may be necessary for the Certified Employee  
17 Health Benefit Allowance.

18 SECTION 11. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 General Revenue Fund of the State Treasury for the fiscal year  
21 ending June 30, 2022, the sum of One Hundred Eighty-eight Million  
22 Four Hundred Fifty-five Thousand Three Hundred Seventy-seven Dollars  
23 (\$188,455,377.00) or so much thereof as may be necessary for the  
24 Support Personnel Health Benefit Allowance.

1 SECTION 12. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2022, the sum of Fifteen Million Twenty-seven  
5 Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much  
6 thereof as may be necessary for administrative and support functions  
7 of the State Department of Education.

8 SECTION 13. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2022, the sum of Two Million Eight  
12 Hundred Ninety-seven Thousand Five Hundred Dollars (\$2,897,500.00)  
13 or so much thereof as may be necessary for transfer to the School  
14 Consolidation Assistance Fund.

15 SECTION 14. There is hereby appropriated to the State Board of  
16 Education from any monies not otherwise appropriated from the  
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
18 fiscal year ending June 30, 2020, the sum of Nine Hundred Thirty  
19 Thousand Three Hundred Ninety-nine Dollars (\$930,399.00) or so much  
20 thereof as may be necessary for transfer to the School Consolidation  
21 Assistance Fund.

22 SECTION 15. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2022, the sum of Two Million Eight  
2 Hundred Ninety-seven Thousand Five Hundred Dollars (\$2,897,500.00)  
3 or so much thereof as may be necessary for transfer to the Teachers'  
4 Retirement System Dedicated Revenue Revolving Fund.

5 SECTION 16. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
8 fiscal year ending June 30, 2020, the sum of Nine Hundred Thirty  
9 Thousand Three Hundred Ninety-nine Dollars (\$930,399.00) or so much  
10 thereof as may be necessary for transfer to the Teachers' Retirement  
11 System Dedicated Revenue Revolving Fund.

12 SECTION 17. There is hereby appropriated to the Oklahoma Arts  
13 Council from any monies not otherwise appropriated from the General  
14 Revenue Fund of the State Treasury for the fiscal year ending June  
15 30, 2022, the sum of Three Million Four Thousand Two Hundred Five  
16 Dollars (\$3,004,205.00) or so much thereof as may be necessary to  
17 perform the duties imposed upon the Oklahoma Arts Council by law.

18 SECTION 18. There is hereby appropriated to the State Board of  
19 Career and Technology Education from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury for  
21 the fiscal year ending June 30, 2022, the sum of One Hundred Thirty-  
22 four Million Six Hundred Forty-one Thousand Seven Hundred Twenty-  
23 three Dollars (\$134,641,723.00) or so much thereof as may be

1 necessary to perform the duties imposed upon the State Board of  
2 Career and Technology Education by law.

3 SECTION 19. There is hereby appropriated to the State Board of  
4 Career and Technology Education from any monies not otherwise  
5 appropriated from the Oklahoma Education Lottery Trust Fund of the  
6 State Treasury for the fiscal year ending June 30, 2022, the sum of  
7 Three Million One Hundred Eighty-seven Thousand Two Hundred Fifty  
8 Dollars (\$3,187,250.00) pursuant to paragraph 2 of subsection E of  
9 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
10 the State Board of Career and Technology Education for the education  
11 and general operating budgets of the institutions and for other  
12 programs, construction, renovations or repairs administered by the  
13 State Board of Career and Technology Education.

14 SECTION 20. There is hereby appropriated to the State Board of  
15 Career and Technology Education from any monies not otherwise  
16 appropriated from the Oklahoma Education Lottery Trust Fund of the  
17 State Treasury for the fiscal year ending June 30, 2020, the sum of  
18 One Million Twenty-three Thousand Four Hundred Thirty-nine Dollars  
19 (\$1,023,439.00) pursuant to paragraph 2 of subsection E of Section  
20 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
21 Board of Career and Technology Education for the education and  
22 general operating budgets of the institutions and for other  
23 programs, construction, renovations or repairs administered by the  
24 State Board of Career and Technology Education.

1 SECTION 21. There is hereby appropriated to the Office of  
2 Educational Quality and Accountability from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2022, the sum of One Million Sixty-  
5 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much  
6 thereof as may be necessary to perform the duties imposed upon the  
7 Office of Educational Quality and Accountability by law. Of those  
8 funds appropriated, the sum of Sixty Thousand Dollars (\$60,000.00)  
9 shall be deposited in the Teacher Certification Scholarship  
10 Revolving Fund created pursuant to Section 6-187C of Title 70 of the  
11 Oklahoma Statutes. Of those funds appropriated, the sum of One  
12 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in  
13 the Education Leadership Oklahoma Revolving Fund created pursuant to  
14 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

15 SECTION 22. There is hereby appropriated to the Office of  
16 Educational Quality and Accountability from any monies not otherwise  
17 appropriated from the Special Cash Fund of the State Treasury the  
18 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much  
19 thereof as may be necessary to perform the duties imposed upon the  
20 Office of Educational Quality and Accountability by law.

21 SECTION 23. There is hereby appropriated to the Oklahoma  
22 Educational Television Authority from any monies not otherwise  
23 appropriated from the General Revenue Fund of the State Treasury for  
24 the fiscal year ending June 30, 2022, the sum of Three Million Two

1 Hundred Four Thousand Four Dollars (\$3,204,004.00) or so much  
2 thereof as may be necessary to perform the duties imposed upon the  
3 Oklahoma Educational Television Authority by law.

4 SECTION 24. There is hereby appropriated to the Oklahoma State  
5 Regents for Higher Education from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury for  
7 the fiscal year ending June 30, 2022, the sum of Five Hundred  
8 Eighty-five Million Two Hundred Thirty-seven Thousand Twenty-four  
9 Dollars (\$585,237,024.00) or so much thereof as may be necessary for  
10 allocation by the Oklahoma State Regents for Higher Education  
11 pursuant to the provisions of Article XIII-A of the Oklahoma  
12 Constitution for the education and general operating budgets of the  
13 institutions and for other programs, construction, renovations or  
14 repairs administered by the Oklahoma State Regents for Higher  
15 Education. Of those funds appropriated, the sum of Three Million  
16 One Hundred Forty-nine Thousand Eight Hundred Ninety-seven Dollars  
17 (\$3,149,897.00) shall be transferred to the Oklahoma Tuition  
18 Equalization Grant Trust Fund to implement the provisions of the  
19 Oklahoma Tuition Equalization Grant Act.

20 SECTION 25. The Oklahoma State Regents for Higher Education are  
21 hereby authorized to expend during the fiscal year ending June 30,  
22 2022, the sum of Forty-seven Million Three Hundred Seventy-two  
23 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
24 Higher Education Capital Revolving Fund of the State Treasury for

1 allocation by the Oklahoma State Regents for Higher Education  
2 pursuant to the provisions of Article XIII-A of the Oklahoma  
3 Constitution for the education and general operating budgets of the  
4 institutions and for other programs, construction, renovations or  
5 repairs administered by the Oklahoma State Regents for Higher  
6 Education.

7 SECTION 26. The Oklahoma State Regents for Higher Education are  
8 hereby authorized to expend during the fiscal year ending June 30,  
9 2022, the sum of Forty-seven Million Three Hundred Seventy-two  
10 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
11 Oklahoma Student Aid Revolving Fund of the State Treasury for  
12 allocation by the Oklahoma State Regents for Higher Education  
13 pursuant to the provisions of Article XIII-A of the Oklahoma  
14 Constitution for the education and general operating budgets of the  
15 institutions and for other programs, construction, renovations or  
16 repairs administered by the Oklahoma State Regents for Higher  
17 Education.

18 SECTION 27. There is hereby appropriated to the Oklahoma State  
19 Regents for Higher Education from the Master Teacher Program Fund  
20 (Fund 713) the sum of Eighty-six Million Six Hundred Thousand  
21 Dollars (\$86,600,000.00) or so much thereof as may be necessary for  
22 allocation by the Oklahoma State Regents for Higher Education  
23 pursuant to the provisions of Article XIII-A of the Oklahoma  
24 Constitution for the education and general operating budgets of the

1 institutions and for other programs, construction, renovations or  
2 repairs administered by the Oklahoma State Regents for Higher  
3 Education.

4 SECTION 28. There is hereby appropriated to the Oklahoma State  
5 Regents for Higher Education from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury for  
7 the fiscal year ending June 30, 2022, the sum of Eleven Million  
8 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars  
9 (\$11,764,823.00) or so much thereof as may be necessary for  
10 expenditures for concurrent enrollment pursuant to Section 628.13 of  
11 Title 70 of the Oklahoma Statutes.

12 SECTION 29. There is hereby appropriated to the Oklahoma State  
13 Regents for Higher Education from any monies not otherwise  
14 appropriated from the Oklahoma Education Lottery Trust Fund of the  
15 State Treasury for the fiscal year ending June 30, 2022, the sum of  
16 Twenty-two Million Eight Hundred Ninety Thousand Two Hundred Fifty  
17 Dollars (\$22,890,250.00) pursuant to paragraph 2 of subsection E of  
18 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
19 the Oklahoma State Regents for Higher Education pursuant to the  
20 provisions of Article XIII-A of the Oklahoma Constitution for  
21 construction, renovations or repairs administered by the Oklahoma  
22 State Regents for Higher Education or for any other purpose  
23 authorized by paragraph 2 of subsection E of Section 713 of Title 3A  
24 of the Oklahoma Statutes.

1 SECTION 30. There is hereby appropriated to the Oklahoma State  
2 Regents for Higher Education from any monies not otherwise  
3 appropriated from the Oklahoma Education Lottery Trust Fund of the  
4 State Treasury for the fiscal year ending June 30, 2020, the sum of  
5 Seven Million Three Hundred Fifty Thousand One Hundred Fifty-three  
6 Dollars (\$7,350,153.00) pursuant to paragraph 2 of subsection E of  
7 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
8 the Oklahoma State Regents for Higher Education pursuant to the  
9 provisions of Article XIII-A of the Oklahoma Constitution for  
10 construction, renovations or repairs administered by the Oklahoma  
11 State Regents for Higher Education or for any other purpose  
12 authorized by paragraph 2 of subsection E of Section 713 of Title 3A  
13 of the Oklahoma Statutes.

14 SECTION 31. There is hereby appropriated to the Oklahoma State  
15 Regents for Higher Education from any monies not otherwise  
16 appropriated from the General Revenue Fund of the State Treasury for  
17 the fiscal year ending June 30, 2022, the sum of Four Million Two  
18 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars  
19 (\$4,232,974.00) or so much thereof as may be necessary for the  
20 general operating budget of the Administrative Offices of the  
21 Oklahoma State Regents for Higher Education.

22 SECTION 32. There is hereby appropriated to the Commissioners  
23 of the Land Office from any monies not otherwise appropriated from  
24 the Commissioners of the Land Office Fund of the State Treasury for

1 the fiscal year ending June 30, 2022, the sum of Eight Million Three  
2 Hundred Seventy-nine Thousand Two Hundred Seventy-six Dollars  
3 (\$8,379,276.00) or so much thereof as may be necessary to perform  
4 the duties imposed upon the Commissioners of the Land Office by law.

5 SECTION 33. There is hereby appropriated to the Oklahoma  
6 Department of Libraries from any monies not otherwise appropriated  
7 from the General Revenue Fund of the State Treasury for the fiscal  
8 year ending June 30, 2022, the sum of Four Million Three Hundred  
9 Forty-six Thousand Three Hundred Fifteen Dollars (\$4,346,315.00) or  
10 so much thereof as may be necessary to perform the duties imposed  
11 upon the Oklahoma Department of Libraries by law.

12 SECTION 34. There is hereby appropriated to the Physician  
13 Manpower Training Commission from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury for  
15 the fiscal year ending June 30, 2022, the sum of Six Million Five  
16 Hundred Forty-six Thousand Eight Hundred Seventy-seven Dollars  
17 (\$6,546,877.00) or so much thereof as may be necessary to perform  
18 the duties imposed upon the Physician Manpower Training Commission  
19 by law.

20 SECTION 35. There is hereby appropriated to the Physician  
21 Manpower Training Commission from any monies not otherwise  
22 appropriated from the Special Cash Fund of the State Treasury the  
23 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much  
24

1 thereof as may be necessary to perform the duties imposed upon the  
2 Physician Manpower Training Commission by law.

3 SECTION 36. There is hereby appropriated to the Board of  
4 Trustees of the Oklahoma School of Science and Mathematics from any  
5 monies not otherwise appropriated from the General Revenue Fund of  
6 the State Treasury for the fiscal year ending June 30, 2022, the sum  
7 of Six Million Eight Hundred Eleven Thousand Three Hundred Seventy-  
8 three Dollars (\$6,811,373.00) or so much thereof as may be necessary  
9 to perform the duties imposed upon the Board of Trustees of the  
10 Oklahoma School of Science and Mathematics by law.

11 SECTION 37. There is hereby appropriated to the Oklahoma Center  
12 for the Advancement of Science and Technology from any monies not  
13 otherwise appropriated from the General Revenue Fund of the State  
14 Treasury for the fiscal year ending June 30, 2022, the sum of  
15 Fifteen Million Two Hundred Ninety-six Thousand Five Hundred Forty-  
16 two Dollars (\$15,296,542.00) or so much thereof as may be necessary  
17 to perform the duties imposed upon the Oklahoma Center for the  
18 Advancement of Science and Technology by law. Of those funds  
19 appropriated, the sum of Seven Million Six Hundred Eighteen Thousand  
20 Six Hundred Seventeen Dollars (\$7,618,617.00) shall be deposited in  
21 the Research Support Revolving Fund, created pursuant to Section  
22 5060.11 of Title 74 of the Oklahoma Statutes, provided One Million  
23 Five Hundred Thousand Dollars (\$1,500,000.00) of these funds shall  
24 be dedicated to Applied Research and Development for Industry

1 Innovation. Of those funds appropriated, the sum of Two Million  
2 Seven Hundred Fifty-nine Thousand Three Hundred Eight Dollars  
3 (\$2,759,308.00) shall be deposited in the Seed-capital Revolving  
4 Fund, created pursuant to Section 5060.21 of Title 74 of the  
5 Oklahoma Statutes.

6 FINANCE

7 SECTION 38. There is hereby appropriated to the Oklahoma  
8 Department of Commerce from any monies not otherwise appropriated  
9 from the General Revenue Fund of the State Treasury for the fiscal  
10 year ending June 30, 2022, the sum of Twenty-two Million Seventy-  
11 seven Thousand Six Hundred Eighty Dollars (\$22,077,680.00) or so  
12 much thereof as may be necessary to perform the duties imposed upon  
13 the Oklahoma Department of Commerce by law.

14 SECTION 39. There is hereby appropriated to the Rural Economic  
15 Action Plan Fund from any monies not otherwise appropriated from the

4 Treasury for the fiscal year ending June 30, 2021, the sum of Seven  
5 Million Five Hundred Thousand Dollars (\$7,500,000.00) or so much  
6 thereof as may be necessary to implement the provisions set forth in  
7 Section 908 of Title 62 of the Oklahoma Statutes.

8 SECTION 143. There is hereby appropriated to the State-Tribal  
9 Litigation Revolving Fund created pursuant to Section 1 of Enrolled  
10 House Bill No. 2951 of the 1st Session of the 58th Oklahoma  
11 Legislature from any monies not otherwise appropriated from the  
12 General Revenue Fund of the State Treasury for the fiscal year  
13 ending June 30, 2021, the sum of Ten Million Dollars  
14 (\$10,000,000.00) to be budgeted and expended as authorized by law.

15 SECTION 144. There is hereby appropriated to the Office of the  
16 State Treasurer from any monies not otherwise appropriated from the  
17 Cash-flow Reserve Fund (Fund 090) of the State Treasury the sum of  
18 Five Million Dollars (\$5,000,000.00) or so much thereof as may be  
19 necessary for the modernization of the treasury management software  
20 system.

21 SECTION 145. There is hereby appropriated to the Oklahoma  
22 Department of Emergency Management and Homeland Security from any  
23 monies not otherwise appropriated from the General Revenue Fund of  
24 the State Treasury for the fiscal year ending June 30, 2021, the sum

1 of One Million Six Hundred Thousand Dollars (\$1,600,000.00) for the  
2 purpose of expanding weather radar infrastructure in the state.

3 SECTION 146. There is hereby appropriated to the Oklahoma Quick  
4 Action Closing Fund created pursuant to Section 48.2 of Title 62 of  
5 the Oklahoma Statutes from any monies not otherwise appropriated  
6 from the General Revenue Fund of the State Treasury for the fiscal  
7 year ending June 30, 2021, the sum of Twenty Million Dollars  
8 (\$20,000,000.00) to be budgeted and expended by the Governor as  
9 authorized by law.

10 SECTION 147. There is hereby appropriated to The State  
11 Emergency Fund, created pursuant to Section 139.42 of Title 62 of  
12 the Oklahoma Statutes, from any monies not otherwise appropriated  
13 from the General Revenue Fund of the State Treasury for the fiscal  
14 year ending June 30, 2021, the sum of Five Million Dollars  
15 (\$5,000,000.00) or so much thereof as may be necessary for matching  
16 federal disaster funds and for other disaster-related assistance.

17 SECTION 148. There is hereby appropriated to the Department of  
18 Public Safety from any monies not otherwise appropriated from the  
19 General Revenue Fund of the State Treasury for the fiscal year  
20 ending June 30, 2021, the sum of Six Million Six Hundred Twenty-two  
21 Thousand Five Hundred Seven Dollars (\$6,622,507.00) for the purpose  
22 of expediting and facilitating the issuance of REAL ID compliant  
23 driver licenses and identifications.

1 SECTION 149. There is hereby appropriated to the Oklahoma  
2 Department of Commerce from any monies not otherwise appropriated  
3 from the General Revenue Fund of the State Treasury for the fiscal  
4 year ending June 30, 2021, the sum of Fifteen Million Dollars  
5 (\$15,000,000.00) for the purpose of funding and implementing a  
6 business incubator program.

7 SECTION 150. Sections 1 through 131 of this act shall become  
8 effective July 1, 2021.
