15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:										
16	SECTION 1. AMENDATORY 70 O.S. 2021, Section 1-111, is										
17	amended to read as follows:										
18	Section 1-111. A. Except as otherwise provided for by law, a										
19	school day shall consist of not less than six (6) hours devoted to										
20	school activities. A district board of education may elect to										
21	extend the length of one (1) or more school days to more than six										
22	(6) hours and reduce the number of school days as long as the total										
23	amount of classroom instruction time is not less than one thousand

1 eighty (1,080) hours per year as required pursuant to Section 1-109
2 of this title.

A school day for nursery, early childhood education, 3 в. 4 kindergarten, and alternative education programs shall be as 5 otherwise defined by law or as defined by the State Board of Education. Except as otherwise provided for in this subsection, not 6 7 more than one (1) school day shall be counted for attendance purposes in any twenty-four-hour period. Two (2) school days, each 8 9 consisting of not less than six (6) hours, may be counted for 10 attendance purposes in any twenty-four-hour period only if one of 11 the school days is for the purpose of parent-teacher conferences 12 held as provided for in Section 1-109 of this title.

13 C. Students Except as provided in subsection D of this section, 14 students absent from school in which they are regularly enrolled may 15 be considered as being in attendance if the reason for such absence 16 is to participate in scheduled school activities under the direction 17 and supervision of a regular member of the faculty or to participate 18 in an online course approved by the district board of education. 19 The State Board of Education shall adopt rules to provide for the 20 implementation of supplemental online courses which shall include, 21 but not be limited to, provisions addressing the following:

2. A student admission process administered through the
 district of residence, which provides the ability for the student to
 enroll in individual courses;

4 3. A process by which students are not denied the opportunity 5 to enroll in educationally appropriate courses by school districts. For the purposes of this section, "educationally appropriate" means 6 any instruction that is not substantially a repeat of a course or 7 portion of a course that the student has successfully completed, 8 9 regardless of the grade of the student, and regardless of whether a 10 course is similar to or identical to the instruction that is 11 currently offered in the school district;

12 4. Creation of a system which provides ongoing enrollment13 access for students throughout the school year;

14 5. A grace period of fifteen (15) calendar days from the first 15 day of an online course for student withdrawal from an online course 16 without academic penalty;

17 6. Mastery of competencies for course completion rather than18 Carnegie units;

Student participation in extracurricular activities in 20 accordance with school district eligibility rules and policies and 21 any rules and policies of a private organization or association 22 which provides the coordination, supervision, and regulation of the 23 interscholastic activities and contests of schools;

8. Parent authorization for release of state test results to
 online course providers, on a form developed by the State Department
 of Education; and

9. A review process to identify and certify online course5 providers and a uniform payment processing system.

D. Except as provided in paragraph 3 of this subsection,
students absent from school in which they are regularly enrolled
shall be given an excused absence if the reason for such absence is
to participate in scheduled 4-H activities or programs as approved
by the county 4-H educator.

9 E. Each district board of education shall adopt policies and procedures that conform to rules for online courses as adopted by 10 11 the State Board. Such policies shall include criteria for approval 12 of the course, the appropriateness of the course for a particular 13 student, authorization for full-time students to enroll in online 14 courses, and establishing fees or charges. No district shall be 15 liable for payment of any fees or charges for any online course for 16 a student who has not complied with the district's policies and 17 procedures. School districts shall not deny students the 18 opportunity to enroll in educationally appropriate courses and shall 19 provide an admissions process which includes input from the student, 20 the parent or quardian of the student, and school faculty.

E. <u>F.</u> Districts shall require students enrolled in online
 courses to participate in the Oklahoma School Testing Program Act.
 Students participating in online courses from a remote site will be
 responsible for providing their own equipment and Internet access,

unless the district chooses to provide the equipment. Credit may
 not be granted for such courses except upon approval of the State
 Board of Education and the district board of education.

4 F. G. Districts may provide students with opportunities for 5 blended instruction. "Blended instruction" shall mean a combination 6 of brick-and-mortar learning and virtual learning environments that 7 includes elements of a student's control over place, pace and path 8 of learning. A student in blended instruction may work on virtual courses at home or at school in a blended flex lab but shall 9 10 participate in at least one unit or set of competencies as defined 11 by Section 11-103.6 of this title at a physical school building in a 12 traditional classroom setting which is the academic equivalent of 13 one (1) hour per day for each instructional day in the school year 14 as defined by Section 1-109 of this title.
