11 An Act relating to abortion; amending Section 18,  
12 Chapter 308, O.S.L. 2021, which relates to contingent  
13 effective date; modifying applicability of certain  
14 provisions; modifying conditions under which certain  
15 provisions will become effective; repealing Sections  
16 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16,  
17 and 17, Chapter 308, O.S.L. 2021, which relate to  
18 abortion; providing for noncodification; and  
19 declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law not to be  
22 codified in the Oklahoma Statutes reads as follows:

23 This act shall be known and may be cited as the "Oklahoma  
24 Outlawed This Act in 1910 Act".

SECTION 2. AMENDATORY Section 18, Chapter 308, O.S.L.  
2021, is amended to read as follows:

1 Section 18. ~~This act~~ Section 1, Chapter 308, O.S.L. 2021 shall  
2 only become effective ~~on and after the certification of~~ when the  
3 Attorney General certifies that:

4 1. The United States Supreme Court ~~overrules the central~~  
5 ~~holding of~~ has overruled in whole or in part Roe v. Wade, 410 U.S.  
6 113 (1973), ~~reaffirmed by~~ and Planned Parenthood of Southeastern  
7 Pennsylvania v. Casey, 505 U.S. 833 (1992), ~~thereby restoring to~~  
8 such that the State of Oklahoma ~~the authority to prohibit abortion~~  
9 may enforce Section 861 of Title 21 of the Oklahoma Statutes or  
10 enact a similar statute prohibiting abortion throughout pregnancy;

11 or

12 2. An amendment to the United States Constitution is adopted  
13 ~~that restores to~~ such that the State of Oklahoma ~~the authority to~~  
14 ~~prohibit abortion~~ may enforce Section 861 of Title 21 of the  
15 Oklahoma Statutes or enact a similar statute prohibiting abortion  
16 throughout pregnancy.

17 SECTION 3. REPEALER Sections 2, 3, 4, 5, 6, 7, 8, 9, 10,  
18 11, 12, 13, 14, 15, 16, and 17, Chapter 308, O.S.L., are hereby  
19 repealed.

20 SECTION 4. It being immediately necessary for the preservation  
21 of the public peace, health or safety, an emergency is hereby  
22 declared to exist, by reason whereof this act shall take effect and
