10 FLOOR SUBSTITUTE

11 An Act relating to oil and gas; creating the Hydrogen
12 Production, Transportation and Infrastructure Task
13 Force; providing for membership of task force;
14 providing duties of task force; requiring a quorum
15 for certain action; requiring task force meet with
16 certain frequency; authorizing the chair to call
17 meetings; subjecting meetings to Oklahoma Open
18 Meeting Act and the Oklahoma Open Records Act;
19 providing that members receive no compensation;
20 requiring certain report by certain date; requiring
21 task force report to certain persons; providing for
22 noncodification; providing an effective date; and
23 declaring an emergency.

24 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law not to be
codified in the Oklahoma Statutes reads as follows:

There is hereby created the Hydrogen Production, Transportation
and Infrastructure Task Force until December 31, 2021.

- 1 A. The task force shall be comprised of ten (10) members as
2 follows:
- 3 1. The chair shall be the Secretary of Energy and Environment;
- 4 2. The co-chairs shall be:
- 5 a. one member appointed by the President Pro Tempore of
6 the Senate, and
- 7 b. one member appointed by the Speaker of the House of
8 Representatives;
- 9 3. Two members shall be:
- 10 a. one member appointed by the President Pro Tempore of
11 the Senate, and
- 12 b. one member appointed by the Speaker of the House of
13 Representatives; and
- 14 4. Five members shall be appointed by the chair of the task
15 force as follows:
- 16 a. a member representing the Secretary of Commerce,
- 17 b. a member representing the Secretary of Transportation,
- 18 c. a member representing the Corporation Commission,
- 19 d. a member representing the Oklahoma Water Resources
20 Board, and
- 21 e. a member representing the Oklahoma Center for Science
22 and Technology.

1 B. A quorum of the task force shall be required to approve any
2 final action of the task force. A quorum shall be determined by the
3 chair of the task force.

4 C. The task force shall meet at least once per month. The
5 chair shall call the first meeting and all subsequent meetings shall
6 be made at the call of the chair.

7 D. The task force shall:

8 1. Hold at least one meeting that focuses on the following
9 issues regarding hydrogen production:

- 10 a. the use and availability of water resources,
- 11 b. availability of cost competitive power necessary for
12 producing hydrogen,
- 13 c. incentives and taxation necessary to encourage
14 development of hydrogen technology, infrastructure and
15 transportation, and
- 16 d. development of a state-wide roadmap for a hydrogen
17 economy including but not limited to infrastructure,
18 production, distribution, transportation and off-taker
19 market uses; and

20 2. Hold at least one meeting that focuses on the distribution
21 of hydrogen including but not limited to:

- 22 a. investigating the viability of utilizing the existing
23 pipeline infrastructure in this state to move hydrogen
24 fuel,

- 1 b. investigating the existing and potential needs of the
2 pipeline industry to integrate hydrogen fuel, and
3 c. investigating existing and potentially necessary
4 pipeline safety standards for distribution of hydrogen
5 fuel.

6 E. The chair and co-chairs shall invite representatives
7 including but not limited to the following list, to participate in
8 the meetings regarding issues relevant to their industry:

- 9 1. Representatives of companies producing, or looking to
10 produce hydrogen;
11 2. Representatives of oil and gas midstream service providers;
12 3. Representatives of regulated natural gas distribution
13 companies;
14 4. Representatives of electric service providers; and
15 5. Representatives of electric energy developers.

16 F. The meetings of the task force shall be subject to the
17 Oklahoma Open Meeting Act and the Oklahoma Open Records Act.

18 G. The members of the task force shall receive no compensation
19 or travel reimbursement.

20 H. The task force shall submit a report of its findings and
21 recommendations including fiscal impact statements on all of the
22 recommendations of the task force no later than December 1, 2021, to
23 the Governor, the President Pro Tempore of the Senate and the
24 Speaker of the House of Representatives.

1 SECTION 2. This act shall become effective July 1, 2021.

2 SECTION 3. It being immediately necessary for the preservation
3 of the public peace, health or safety, an emergency is hereby
4 declared to exist, by reason whereof this act shall take effect and
5 be in full force from and after its passage and approval.
